'Reuters' team member dead in missile attack

Kyiv: A British safety adviser working with a team of journalists from *Reuters* was killed after a Russian missile struck a hotel in the Ukrainian city of Kramatorsk, the organisation confirmed Monday. Ryan Evans, 38, was staying at the Hotel Sapphire with colleagues in Donetsk region when it was hit by a Russian missile Saturday night. Two other members of the six-person Reuters crew were hospitalised with injuries. Local officials said the hotel was struck by an Iskander-M Russian ballistic missile leaving the reporters with blast injuries, concussions and cuts on the body

Gunmen kill 37 in **Pak's Balochistan**

Karachi: Heavily-armed gunmen killed at least 37 people in two separate attacks in Pakistan's Balochistan province Monday, as insurgent violence spiked in the restive region. In the first incident, 23 people from Puniab province were killed in a targeted attack in Musakhel district after gunmen offloaded them from buses and checked their identities. In another attack, gunmen killed at least 14 people, including six police officers, in Qalat district.

Laxmanananda murder report soon: Law Min

Bhubaneswar, August 26: Amid growing calls to release the judicial commission report on the killing of VHP leader Swami Laxmanananda Saraswati, Law Minister Prithiviraj Harichandan said Monday that the state government will soon take a decision on the matter.

Harichandan made the observation while speaking to reporters on the 16th death anniversary of Saraswati. He informed that Chief Minister Mohan Charan Majhi is aware of the situation and has already discussed it.

The demand for the release of the report has been voiced by several organisations, including the Odisha unit of VHP, Bajrang Dal, and the Swami Laxmanananda Saraswati Smruti Committee, all supported by the RSS

Saraswati and four of his associates were gunned down at Jalespeta Ashram in Kandhamal district August 23, 2008, during Janmashtami celebrations, leading to widespread violence that resulted in 43 deaths.

The Odisha government had set up a Commission of Inquiry, initially led by Justice Sarat Mohapatra and later by Justice AS Naidu, to investigate



Saraswati's death. Although the Commission submitted its report in 2015, the previous BJD government delayed its release, according to information provided by state VHP leader S Satpathy.

Kandhamal MP Sukanta Kumar Panigrahi demanded a CBI probe into the case August 23. He cited concerns that the masterminds behind the killings remain at large.

A petition was also filed in the Orissa High Court seeking a CBI probe into the gruesome murders. Hearing the plea filed by advocate Debasis Hota, the High Court had issued a notice to the Odisha government January 2 this year. However, opposing the CBI inquiry, the state government in March urged the Orissa High Court to dismiss the petition for a CBI

investigation.

50kg gold, 2qtl silver Squads reassigned for pachyderm protection pachyderm protection Seized near airport Bhubaneswar, August 26:

Bhubaneswar, August 26: Under scrutiny for the death of over 40 elephants so far this fiscal, the Forest department has reassigned protection squads from various divisions to circle levels for more effective wildlife protection.

In a recent letter to all regional chief conservators of forests (RCCFs), the office of the Principal Chief Conservator of Forests (PCCF) Susanta Nanda has said that despite having 397 squads deployed in different ranges and divisions for protection and conservation of wildlife, more than 40 elephant. deaths have been reported during the current financial year. The letter was issued last week, sources stated here Monday.

The letter stated that while the services of these squads are crucial, the leadership necessary for their effective utilisation and the standard operating procedures (SOPs) for field operations - such as tracking elephants and undertaking protection activities - have



in this regard, and the performance of the squads has not been reported to the wildlife headquarters.

The letter noted that 'signs of permanency have crept in', resulting in neither effective patrolling nor protection of wildlife and their habitats, with no action taken against underperforming squads.

To rectify the situation, the Forest department has decided to reallocate the squads from forest divisions to the RCCFs for better field deployment and patrolling.

The department advised the RCCFs to 'not disengage any performing squad members as long as they fulfil the requirements in the field'. RCCFs have also been instructed to mobilise squads from other divisions as needed to ensure effective wildlife protection and management. Special care has to be taken for protection of elephants, the letter said.







1,274 held, over ₹20 crore worth illicit liquor seized

Bhubaneswar, August 26: A staggering 1,274 persons have been arrested and a record 2,209 cases made out by the Excise department during the statewide crackdown against illicit country liquor and fermented brew manufacturers across the state in the last one week following the hooch tragedy at Chikiti in Ganiam district August 19.

A senior Excise official told Orissa POST Monday that a total of 1,15,822 litres of illicit country liquor and 1.02,237 kg fermented brew have been seized during the raids at manufacturing dens by various Excise units in the state. The retail price of the seized contraband has been estimated to be of over Rs 20 crore.

The officials also seized 132 vehicles used in the transportation of the illicit liquor consignments, leading to the arrest of 70 vehicle owners. "They are being questioned to ascertain if they, too, were part of the illicit liquor syndicates," the of-

Only Monday, the department



arrested 125 persons from various parts of the state and registered 341 offences in connection with the recovery of 21,341 litres of illicit spirits and 2,28,762 kg of fermented brew. The raids, carried out on the instruction of Excise Commissioner Narsingha Bhol, also resulted in the seizure of 20 vehicles and arrest of 10 of their owners, the official said adding that all the accused have been forwarded to courts.

-n order to bolster cases against habitual offenders during the present crackdown, the Excise sleuths are digging out their past cases and clubbing those with the fresh case during their production in the case

We are making the entry of their past cases in our case diary, remand as well as the chargesheet (at a later stage) so as to convince the court/s not to take a lenient view of their notoriety," a senior Excise official said.

Simultaneously, the sleuths have also stepped up efforts to intensify crackdown on the smuggling syndicates that ensure a steady supply of illicit spirits and fermented brew to big cities like Cuttack and Bhubaneswar using various modes of transport, especially buses.

"We have identified those production and distribution points in Mayurbhanj, Athagarh, Khalikote and Dhenkanal," the official said adding that massive crackdowns are on the anvil.

All isn't well with adopted villages: NHRC seeks report

Bhubaneswar, August 26: The National Human Rights Commission (NHRC) has sought detailed responses from the Ministry of Rural Development's Secretary and state's Chief Secretary within eight weeks on the plight of the residents of villages 'adopted' by public sector banks (PSBs), MPs and MLAs.

The NHRC move came while hearing a plea filed by senior lawyer Radhakanta Tripathy. The petitioner drew the apex rights body's attention towards lack of basic amenities and bare necessities in the villages 'adopted' on record by various organs of democracy and institutions in the country.

In his plea, Tripathy alleged that residents, especially the poor belonging to the Scheduled Tribe (ST) community, in villages - like Jalanga in Bhadrak district - adopted by the Reserve Bank of India (RBI) under Samagra Gramin Vikas Yojana (SGVY) have been leading a miserable life.

"RBI governor D Subbarao had launched a financial outreach programme in Jalanga December 3, 2009. Later, UCO Bank adopted Jalanga to transform it into a model village under the SGVY. During his visit to Jalanga in February 2013, Subbarao heard grievances against UCO Bank. But to no avail," said Tripathy.

He claimed that to date, the five villages – Jalanga, Chandlpur, Pokatunga, Chhatabara and Bhedabahal of the state - which have been adopted by the RBI under SGVY did not reveal any improvement even after 14 years

of their adoption. The situation of villages



adopted by MPs, MLAs and corporate is no different, the petitioner said.

He said no comprehensive database regarding the adopted villages in India has been prepared by the Ministry of Rural Development. It is believed that more than 10,000 villages have been adopted by various institutions, MPs and MLAs in the

'Mere adoption on records,

spending money with the nexus of corrupt persons in the name of poverty and backwardness further worsens the condition of life of the adopted villagers and weakens their belief in the democratic setup," Tripathy said.

Periodic, systematic assessment and evaluation of the living conditions and quality of life with happiness index of the residents of adopted villagers should be given utmost importance, Tripathy said.

The rights activist urged the NHRC to seek a comprehensive database on the adopted villages in states, including Odisha, and Union Territories and make a study on the development of the villagers so far as bare necessities of life and basic amenities and improvement of health, education, employment and other

IMD: Heavy rains to lash state for 2 days

New Delhi/Bhubaneswar, August 26: A depression over northwest Madhya Pradesh and adjoining east Rajasthan has intensified into a deep depression, the India Meteorological Department (IMD) said Monday and warned of heavy to extremely heavy rainfall in parts of Konkan, Goa, Maharashtra and Odisha over the next two

At 11:30 pm August 25, the deep depression lay centred near 70 km south-southeast of Chittorgarh, Rajasthan. This system is expected to move westsouthwest, affecting South Rajasthan, and Gujarat, and reaching Saurashtra, Kutch, and parts of Pakistan by August 29, the IMD said in an update issued at 2 am.

The weather department said another low-pressure area is located over Bangladesh and adjoining Gangetic West Bengal. It is likely to intensify further and move towards Gangetic West Bengal, north Odisha, and Jharkhand over the next two days. Issuing a red alert, the IMD said heavy to extremely heavy rainfall is expected in West Madhya Pradesh August 26. Similar conditions are forecast for east and south Rajasthan, Gujarat, Saurashtra and Kutch from August 26 to 29.

Konkan, Goa, Madhya Maharashtra, Odisha, Gangetic West Bengal, and Jharkhand are also expected to receive heavy to extremely heavy rainfall over the next two days, it said.

The IMD has warned of strong winds reaching up to 50 kmph in Madhya Pradesh August 26 and up to 60 kmph in south Rajasthan August 26-27. In Gujarat, nearby Pakistan, north Maharashtra, and the northeast Arabian Sea, strong winds gusting up to 55 kmph are expected on August 26, increasing to 60 kmph August 27 and 28.



Over 11K chickens culled; Health dept issues alert

Bhubaneswar, August 26: The state government has culled over 11.700 chickens in Puri district's Pipli following the detection of the H5N1 strain of avian influenza, an official said Monday.

After mass deaths of chickens at a local poultry farm in Pipli, culling began Saturday and was completed Monday evening. Additional culling in homes and nearby villages will take place Tuesday, the official added.

The Heath department has directed Satya Panigrahi of the state RRT and Sunita Jena, Epidemiologist, SSU to proceed to Puri to investigate and ensure the culling operation as per the guideline.

Director, Public Health Nilakantha Mishra has asked CDMO, Puri, to remain prepared for the protection of human

health due to the ongoing outbreak of bird flu in the district.

Jagannath Nanda, Additional Director of Disease Control, said 13 rapid response teams are handling the culling, with some poultry farm owners conducting culling independently. No other unusual chicken deaths have been reported elsewhere in the state, he added. In response to the outbreak, the state Health department has heightened surveillance and issued an alert.

Bijay Mohapatra, Director of Health Services, emphasised that while bird flu is not new to Odisha, the department is working with stakeholders to manage the situation. He assured that sufficient medicines are available and urged poultry workers to maintain hygiene and wear masks.

Meanwhile, neighbouring West Bengal has reportedly expressed its unwillingness to procure poultry from Odisha following the discovery of avian influenza in chickens at a firm in Pipli area. The West Bengal Poultry Federation informed about this decision Monday.

The H5N1 strain is considered highly pathogenic and can also be transmitted to animals such as pigs, horses, large cats, dogs, and occasionally humans.

The spread of the virus is a concern for governments and the poultry industry due to the devastation it can cause to flocks, the possibility of trade restrictions and the risk of human

Light exercise improves blood flow to children's brain

erforming light-intensity exercises for a short duration was found to have improved the blood flow to children's cerebrum, known to help with cognition, according to a recent study.

The study by Japan's Waseda University enrolled 41 healthy children from fifth-grade elementary to third-year junior high school students to find out how short-term, light-intensity exercises affected the blood flow to prefrontal cortex, located in the cerebrum and known to han-

dle cognitive functions. Researchers focused on exercises that can easily be performed on the spot without special equipment, such as stretching. Most of the exercises were performed

while seated, with movements lasting 10 to 20 seconds.

The team used an imaging technique -- functional near-infrared spectroscopy -- to measure changes in blood flow to the brain by looking at concentrations of oxyhaemoglobin (that carries oxygen from the lungs to the tissues) while at rest and during the exercise.

According to the findings published in the Scientific Reports journal, the researchers found a significant increase in oxyhaemoglobin levels in multiple regions of the prefrontal cortex during all forms of exercise compared to the resting state.

"By combining the types of exercise that easily increase blood flow in the prefrontal corChildren around the world have been shown to insufficiently engage in physical exercise, leading to high levels of sedentary behaviour

It may also be used in the future to prevent cognitive decline in adults and the elderly," said Takashi Naito, one of the authors and a doctoral student at Waseda University.

The authors further wrote that the study implies that shortduration, light-intensity exercises, provided that they entail a certain degree of cognitive and/or physical demands, can activate the prefrontal cortex and increase blood flow.

Previous studies have shown that physical exercise improves cognitive function in many ways such as by improving blood flow to the brain, by causing structural changes in the brain and by promoting the forming of new brain cells, or neurons.

However, as children around the world have been shown to insufficiently engage in physical exercise, leading to high levels of sedentary behaviour, the authors said that the study's results offer potential solu-

The study is a significant step forward in combating sedentary lifestyles and activating brain functions in children, thereby supporting their physical and

mental growth, they said. "Our goal is to develop a lightintensity exercise program that is accessible to everyone, aiming to enhance brain function and reduce children's sedentary behaviour," Naito said.

More than six months after diagnosis with an aneurysm, researchers compared how many people developed a mental health condition, such as anxiety, stress, depression, bipolar and eating disorders, insomnia and alcohol or drug misuse.

The analysis took place over a 10-year period. It found that, when compared to people without an aneurysm, people with an aneurysm were 10 per cent more likely to be diagnosed with a mental health condition

In cases where a mental health condition was diagnosed by a psychiatrist, the difference was even greater, showing a three-fold increased risk.

'Our finding of a higher rate of a severe mental health condition in younger adults with aneurysm underscores the significant psychological burden for this group of patients who may already be dealing with other life stressors, such as building their career and/or raising

a family," Yang noted. The researchers suggest providing support to help patients cope with the stress of the diagnosis may be an important part of comprehensive care.

Keonihar, August 26: This district is known for its huge quantities of iron ore. In fact it is said that Keonjhar is the highest iron ore producing district in India. However, despite bringing huge amounts of revenue to the exchequer both at the state and central levels, the district continues to remain under-developed.

The people here belong mostly to tribal communities and live in poverty. The mineral rich blocks of Joda, Banspal, Hatadihi, Harichandanpur still lack the basic minimum amenities. Unemployment is also high in this district.

The District Mineral Foundation (DMF) fund was expected to play a key role for the overall development. However, the funds are mostly used for

been spent for projects which could have been developed with money provided by the Odisha government," said Subhakanta Nayak, an RTI activist.

"The trustee board of the DMF is not meeting regularly. On many occasions proposals are passed without the necessary approval of the board. Huge amounts have been spent for the appointment of staff in the DMF and most of them are incompetent," Nayak added.

Nayak's opinion was supported by social activist Mukhtar Ahmed. "As DMF fund is Keonjhar's own, hence local needs and employment should be given priority. Funds have been spent on many unnecessary projects and due to lack of proper supervision huge amounts of money has gone to waste due to poor quality work," Ahmed pointed out. According to the DMF website, total funds collected so far are ₹11,541.12 crore (it includes ₹1.731 crore in FY 2023-24 and ₹438 crore in the ongoing FY 2024-25).

So far 3,271 projects have been undertaken and ₹5,308.09 crore has been spent on those. Out of this ₹3.628.25 crore has been spent on 2,592 projects in high priority areas and ₹1,679.85 crore on 679 projects in other.

District Collector and chairman of the DMF trustee board Bishal Singh said, "The data available on the website is wrong. We have spent more money than the figure being shown on the website. We will soon review the projects to find out how many of them are incomplete. Work on various projects is regularly monitored by our technical team.

Woman dies after delivery; medical negligence alleged

Nayagarh, August 26: Tension ran high at Nayagarh District Headquarters Hospital (DHH) following the death of a woman post-delivery as her family members alleged medical negligence, Monday morning. The deceased woman was identified as Sabitri Sethi, 30, a resident of Tentulia village under Jagannath Prasad block of Ganjam district.

Following the death of the woman, police reached and began an investigation. An administrative inquiry by the Health department has also commenced in this regard. Though the mother and newborn son were healthy after delivery, the woman lost her life after receiving a blood transfusion. However, the infant was in good health, it was learnt. It has also been alleged that ₹5,000 was paid to the doctor and additional money was given to the nurse for the operation.

According to the deceased's sister-in-law, Sabitri was admitted to a local health centre after experiencing labour pain. As her condition did not improve, the doctor referred her to the Nayagarh District Headquarters Hospital, where she was admitted Saturday. The doctors suggested surgery as a normal delivery was not possible. After the operation, Sabitri gave birth to a healthy baby boy. Both the mother and the child were stable when they were moved to the ward. However, after the doctor advised a blood transfusion, Sabitri's condition worsened and she eventually lost her life.

Superintendent of Nayagarh DHH, Ajay Kumar Bahinipati, acknowledged the allegation of medical negligence leading to Sabitri's death but stated that no formal complaint has been received. An administrative investigation has started, and the police are conducting their own inquiry, he said. The family initially resisted a post-mortem examination but agreed after persuasion. They are now awaiting the post-mortem report for further clarity.

5 wild boar piglets rescued from well

Taking to X, the Chief Minister described Saraswati as a great social reformer who worked for the wellbeing of the downtrodden and also upheld the local culture. His (Saraswati) dedicated life will all along inspire society, Majhi said.

In October 2013, eight convicts, including Maoist leader Udava, were sentenced to life imprisonment.

Despite significant public interest, the findings of the judicial inquiry, conducted by Justice Sarat Chandra Mohapatra and later Justice AS Naidu, have not yet been made public, even 16 years after the murder.

Tiny Crack

n the second sign of disunity between the BJP-led NDA government and one of its key allies, a senior Janata Dal (United) functionary lacktriangle on 25 August joined leaders of Opposition parties – the Congress, Samajwadi Party (SP), and Aam Aadmi Party (AAP) - to prevail upon the Centre to stop the supply of arms and ammunition to Israel that invaded Gaza following the deadly attacks by Palestinian militant outfit Hamas last October. A statement was issued in Delhi which cannot easily be pushed under the carpet as a tiny crack. However, the importance of this statement, on a day the Middle East witnessed a fresh wave of attacks and retaliatory strikes between Israeli Defense Forces (IDF) and Hezbollah in southern Lebanon, increases because of the timing. This Israeli attack on Hezbollah was its biggest since the full-scale war between the two in 2006.

With the unfolding events, the joint statement issued by the Opposition and JD(U) leaders assumes significance in Indian politics. The first sign of disenchantment demonstrated by the JD(U) was when its President and Bihar CM Nitish Kumar did not show up at a Niti Aayog meeting of Chief Ministers held at New Delhi on 27 July with PM Modi being present. There was no prior information about Nitish's absence.

The NDA government in its previous term, when the BJP was calling the shots having more than the requisite number to survive on its own, had great bonhomie with Israeli Prime Minister Benjamin Netanyahu's government as the common thread running between the two was their antipathy towards Moslems. It may be noted that the JD(U) is a much needed partner in the NDA coalition government and it enjoys the support of a large section of Moslems in its home turf of Bihar.

The Opposition and JD(U) leaders, some parliamentarians among them, condemned the "ongoing Zionist aggression and the heinous genocide of the Palestinian people by Israel." In a strong message to the Modi government, they said India "cannot be complicit" in this.

The statement came after a meeting in New Delhi between the League of Parliamentarians and Al Quds' secretary general Mohammed Makram Balawi. That meeting where Balawi spoke in detail about Israel's alleged violation of international law was jointly organised by JD(U) general secretary KC Tyagi and SP's Rajya Sabha MP Javed Ali Khan. Apart from Tyagi and Khan, SP Lok Sabha MP Mohibullah Nadvi, former MP and Rashtrawadi Samaj Party's ex-president Mohammed Adeeb, AAP MP Sanjay Singh, AAP MLA Pankaj Pushkar, Congress spokesperson Meem Afzal and former Lok Sabha Congress MP Kunwar Danish Ali signed the statement.

In the statement they said they unequivocally condemned the Israeli aggression and the assault, they insisted, was an affront to humanity and a gross violation of international law and the principles of justice

While urging the Centre to stop the supply of arms and ammunition to Israel, the parties said as a nation that has always championed the cause of justice and human rights, India cannot be complicit in this genocide.

These are strong words and coming from a key ally of the NDA government, they can be interpreted as a sign that the BJP will find it difficult to continue with the government's rather ambivalent stand on the raging conflict between Israel and Palestinians. The NDA government has so far not been vocal against Israel's hostilities against Palestinians that have been condemned by different world bodies.

The government's friendly ties with Israel came under scrutiny and attack during its previous term when it was found that it had bought the Pegasus spyware from Israel for domestic spying. It was allegedly used to stifle the voice of protest against the government's policies and its acts of omission and commission. The espionage software is still being used

to keep tabs on journalists, writers, officials, social activists and others. The noise being made by the JD(U) suggests the NDA government's troubles of depending on two of its crucial allies have started surfacing over a least expected issue. KC Tyagi is known in Delhi circles as the main trouble shooter for Bihar CM Nitish Kumar.

fortnight by the minority BJP government of two of its long-held and fiercely-defended policy proposals -- lateral hiring and pensions -- has quickly been traced to either the renewed opposition in the Parliamentary arithmetic or is pictured as a strategic withdrawal in the face of electoral compulsions, given the polls in Haryana and Jammu & Kashmir, to be followed by Maharashtra and Jharkhand.

In the short-term analysis, this reading is indeed true. But beyond the immediate, what it shows is the bind of the BJP which, after all, had not pushed these policies unthinkingly or half-heartedly. These are precisely the policies that fit into the BJP idea of continued and even accelerated reforms, endorsed by its narrow group of industrialist friends and supported by the wider business community. Without doubt, the BJP and its leadership continue to believe in the policies that have come

This was equally so with the abrupt withdrawal of the infamous farm laws in Nov. 2021. Then, like now, the government and Modi himself were seen as desperate to push the new arrangements, but the political capital spent on what was being called monumental reform came then with a monumental lack of intentions. It was the BJP stalwart and former J&K Governor Satyapal Malik who alleged that favoured industrialists had already picked up tracts of land in advance of the law to make a killing as prices soared later.

The current policies have come under fire on issues of undermining social justice, a charge that is already believed to have cost the BJP heavily in the last Lok Sabha polls, by hiring senior government execu-

tives without reservations in the case of lateral hires. In the case of the New Pension Scheme, now discarded, the charge is leaving people to the vagaries of the market. The government employees don't trust the market, just as the farmers did not want an open market system and instead sought MSP guarantees from the government.

This highlights once again the issue of lack of trust of the ordinary citizen in the fairness of the markets and broadly the private sector, and transitively the lack of trust in the BJP-led government which is seen as speaking for the private sector and pushing for its bigger role in the economy. There are two parts to this lack of trust: one is the inherent anti-market tendency of the nation, the other is the added anti-market bias caused by undue closeness between power and private capital.

So after more than two terms with a full-blooded majority and a single leader in command, virtually no opposition on the outside and complete silence on the inside of the party, the BJP has not been able to change the national mindset at least in

terms of economic affairs. Here lies the big collapse for the BJP and the Modi brand of politics, even if the BJP for now continues to hold power at the Centre and in several states. As it pushes to exert its influence and expand its remit, the party will play for a more right-wing agenda, and even test the boundaries, and in the process stir the pot on many other fronts to divert attention, its communal politics included.

In part, this is because the BJP is today a machinery of self-proclaimed strategists and narrative shapers who tend to believe that governance is about telling stories, along the way making them up and then putting in all resources to sell these stories. The BJP is not really taking on the immense political challenge of explaining and then persuading the people to go with the right-wing turns it seeks; it is sneaking it in, and in that it is being met with defeat after defeat. The nation is say ing it cannot be fooled. The fact is that India remains unconvinced on more reforms of the kind on offer.

Take the example from some

seven years ago, when the Economic Survey of India officially noted that: "All states, all societies, have some ambivalence toward the private sector

... But the ambivalence in India seems greater than elsewhere .. It appears that that India has distinctly anti-market beliefs relative to others, even compared to peers with similarly low initial GDP per capita levels.'

In this, the government quoted data from the World Values Survey. Revisiting the latest data points in the same survey tells us that the baseline has not moved in India. Last year, for example, the same survey asked reactions to the statement: "Government ownership of business should be increased." In India, 23.3% of respondents completely agreed with this statement, higher than the number reported for China or even Bangladesh. India sat in the band where Pakistan sits, where a higher 28.7% agreed fully with that statement. In India, a total of over 60% tended to go with that statement than the other end of the scale which said private ownership of business should be increased -- just 11.1% en-

dorsed that fully. We may not need that survey to know that India's economy isn't doing well. Rising inequality, higher than that found during the British Raj according to the World Inequality Lab, coupled with the complete failure on providing decent jobs, the corruption that has seeped in at the top, right into regulatory systems as seen in the case embroiling the head of SEBI, tells us of all that is going wrong. Policies of the last decade have failed, and policy reversals in bits and pieces won't fix the mess.

Protecting workers from extreme heat

crisis disproportionately affects the world's two bilwaves become increasingly freglobal occupational safety and health (OSH) protections against climate-related risks leaves these workers dangerously exposed. Forced to labor in record-breaking temperatures, their health and even lives are in jeopardy.

In 2022, the International Labor Organization (ILO) declared a "safe and healthy working environment" a fundamental right. But although many countries have recognised extreme heat as an occupational hazard and implemented workplace-safety protections, these measures rarely extend to the world's most vulnerable workers: those working informally in fields, landfills, street markets, and homes

More than 2.4 billion workers worldwide are exposed to extreme heat annually. With heat stress projected to increase rapidly over the next few decades, the international community must urgently reform labour-protection frameworks to ensure workers' health, safety, and livelihoods. Without decisive action, millions will continue to suffer needlessly, trapped in a cycle of rising temperatures and hazardous working conditions.

This danger is particularly acute

oday's escalating climate in low- and middle-income countries, where informal jobs account for roughly 90% of total employlion informal workers. As heat ment. While data on these workers' health and safety are limited, quent and intense, the absence of a growing body of research suggests that extreme heat has a profoundly negative impact on their well-being and livelihoods.

For example, research by Women in Informal Employment: Globalizing and Organizing (WIEGO) and the University of Sheffield found that 85% of waste pickers in Brazil experienced heat stress in 2022 and 2023, resulting in serious health risks and reduced productivity. In Delhi, where temperatures breached 50° Celsius in May the death of a 53-year-old laborer prompted the lieutenant governor to issue new guidelines adjusting laborers' working hours and expanding access to drinkable water. As a recent World Health Organization editorial notes, the severe effects of extreme heat on informal workers include an in-

creased risk of skin cancer. Despite recent advances on establishing global OSH standards. policymakers face significant challenges in addressing the issue. Notably, 64% of informal workers are self-employed. Without employers to finance essential safety measures, economically vulnerable workers must use their limited resources to protect them

This weakness reflects a dis-

connect between local and national policymakers. In urban areas, informal workplaces are typically regulated by municipal authorities that rarely coordinate displacement. with national labor agencies responsible for workplace safety. Moreover, informal workers are often stigmatized and seen as an undesirable source of crime and

urban blight. Even when national and local authorities manage to coordinate their efforts, significant gaps remain. India's heat action plans, for example, aim to tackle climaterelated risks across multiple levels of government. But these plans overlook the realities of informal work and the need for targeted interventions at the municipal level, particularly in densely populated urban areas.

While establishing global norms and standards is necessary, they must be translated into concrete measures that protect informal workers in the regions most affected by rising temperatures. In particular, local and municipal authorities must adopt inclusive labor regulations and invest heavily in appropriate infrastructure, including expanded access to potable water, shade, indoor ventilation, and high-quality occupational health services. To prevent the rise in morbidity and mortality rates associated with heat stress, these services must be affordable, adequately funded,

and accompanied by structural shifts at the national level to provide vital income support to workers grappling with climate-related

Informal worker organizations are already leading the way. In Zimbabwe, informal traders have convinced Masvingo's city council to approve public investment in critical urban infrastructure. In India, the Self-Employed Women's Association, one of the world's largest worker organisations for women in informal employment, recently launched its own insurance program that enables beneficiaries to avoid working during dangerous heat waves.

In addition to such workerdriven solutions, OSH protections must be integrated into climate policies. As heat-related hazards continue to evolve and intensify, a staggering number of workers including those in informal employment - face the risk of chronic illness, death, and disability. Without coordinated action, the future of work will be increasingly dangerous and uncertain, leaving millions of workers to face the brunt of the climate crisis.

Pension provision

Sir, This refers to "Assured pension for central govt workers," Orissa Post, Aug 25. It's heartening to learn that the Union cabinet, chaired by PM Narendra Modi, approved the Unified Pension Scheme (UPS) that will benefit 23 lakh central government employees. The UPS aims to give assured pension, family pension and assured minimum pension to the beneficiaries. At the same time, the central government has vet to act affirmatively in regard to the pension on higher wages in EPS-95 pension scheme. The Supreme Court ruling on 'Pension on Higher Wages' is yet to fructify after being rolled out in November 2022. In January 2024, after previously extending the deadline for employers to upload wage details and other information for Pension on Higher Wages, the EPFO extended the deadline for employers from December 31, 2023, to May 31, 2024. Since then, there has been no information on any extension of the deadline, nor on the status of pensioners' and members' contributions from the EPFO. The labour minister's reply in Parliament during last session that there is an actuarial deficit in the EPS-95 scheme is discouraging amid the reports that the EPFO is promoting a new rule to calculate the higher pension.

Meanwhile, AMMA Joint Secretary and popular actor Baburaj, who was, in all likelihood, set to take over as Secretary got a rude jolt when a former junior artiste said that she was called to his house in 2019 to discuss a film project and a sexual advance was made on her.

"I brought the complaint to the notice of the police then itself. Now even though our family is based outside Kerala, I will pursue this complaint. I got a call from a woman police official and I have told her (about it),' said the former junior artiste.

Incidentally soon after the resignations of Siddique and Ranjith, the Vijayan government decided to form a high-level police team, comprising four women IPS officers to be led by a male officer.

The team, which was to have its first meeting Tuesday to decide its way forward, held an online meeting Monday itself following more complaints surfacing. It has been decided that it will only be the woman officials who will be meeting and taking statements from the women complainants.

However, Leader of Opposition VD Satheesan expressed his doubts about the team.

We have serious doubts about the Vijayan government and their sincerity in going forward with the probe. What was the need to ask a male police official to lead the team? When the team was constituted, there was not a word mentioned about the Hema Committee, hence we have our own doubts," the Congress leader said.

Meanwhile, there are claims that the Vijayan government tried its best to protect Ranjith because of his alleged closeness to the son of CPI-M state Secretary MV Govindan, who is also a budding film per-

A section of the CPI-M is also upset with Mukesh and it surfaced when the Minister of State for Higher Education R Bindhu said that a probe is necessary into the allegations.

"Let it take place as no innocent person should be taken to task, while the wrongdoer should be dealt with," she said.

'Heal in Rajasthan' policy to boost medical tourism

Construction of Ayushman Tower in Sawai Mansingh Hospital, establishment of two Medicity and Marwar Medical University, medical college and nursing college in every district, promotion of telemedicine, many high class medical institutions



in the private sector coming to the state are steps which will boost medical tourism in Rajasthan.

Also, with the provision of portability in the Chief Minister Ayushman Arogya Yojana soon, patients from other states will be able to come here for treatment.

Singh said that due to continuous improvement in health services and availability of treatment at reasonable rates, the possibilities of medical tourism in the state have developed rapidly. Through policy decisions, the state government wants to expand these possibilities further. Other enterprises including pharma and the hotel business will also get a boost from this.

surviving families have been shifted to rented accommodations. All the 728 surviving families from the relief camps were shifted to rented accommodations, they said.

A total of 2,569 people have been shifted to various government quarters and other rented accommodations, authorities added.

The devastating landslides that had hit the hilly Wayanad district July 30 claimed over 200 lives. The landslides had completely wiped out three villages in Wayanad with 119 people still unaccounted for

Jaipur, August 26: In a major crackdown on terror, an Al-Qaeda-inspired module was busted in a joint operation carried out Thursday by the Delhi Police Special Cell and state police forces in Rajasthan, Uttar Pradesh, and Jharkhand, leading to the arrest of 11 persons while six others were detained.

Of those held, six were arrested from the jungles near Bhiwadi in Rajasthan's Khairthal-Tijara district adjacent to Alwar. They were reportedly undergoing weapons training there.

The accused have been iden tified as Hasan Ansari, Enamul Ansari, Altaf Ansari, Arshad Khan, Umar Farooq, and Shahbaz Ansari, all residents of Jharkhand who were staying in Rajasthan for the past few days, police sources said.

'The module, as per the current state of operations, was being led by Ishtiyaq from Ranchi. It was aspiring to declare 'khilafat' and execute serious terrorist activities within the country," a Delhi Police statement said.

However, this time, after getting information about the terror module in Bhiwadi, a joint team of Delhi Police and Rajasthan Police carried out a secret operation and nabbed the six accused along with a cache of arms and ammunition.

Kota. August Environmentalist Bitthal Sanadhya was roaming near the Labhakho and Peepalda areas of the Dabi forest range in Rajasthan's Bundi district when he was told by a forest ranger that the place was a river buried by

debris from illegal mining sites. Stunned by the revelation, Bundi Jal Biradari president Sanadhva -- who draws inspiration from Ramon Magsaysay Award winner Rajendra Singh -- was driven to revive the river, a tributary of the Chambal known locally as the Aeru.

Armed with GPS images of the illegal mining sites and the buried river, he approached



Rajasthan High Court in 2018 and filed a PIL to revive the Aeru in the region.

An eight-kilometre stretch of the Aeru, which covers 40 kilometres through the Bhilwara and Bundi districts before merging into the Chambal, had been buried under debris from illegal

The Aeru originates from Tilaswa Mahadev in Bhilwara and passes through six villages

before entering Bundi at Lamakhoh.

For years, suspected mining mafia illegally mined stones and slabs in the Aeru, turning the river into a dump yard.

'The ranger's response when he said it was part of the Aeru river buried under mining dump stunned me," Sanadhya said.

'Since then, I devoted myself to bringing the river back to life," he added.

Following a five-year battle, the high court last year ordered the Department of Mines & Geology to prepare an action plan for the removal of the mining waste from the river and allocate funds for its implemen-

Complying with the order, Bundi collector Akshay Godara allocated Rs 10 crore from the District Mining Foundation Trust for removing the waste earlier this year. Work on the river revival project, beginning with the removal of the mining debris, started in June and it has already begun to pay dividends.

Crystal-clear water now flows over a more than two-kilometre stretch, with the hope that the Aeru will once again enrich the riverbanks as it had previously

At least 15 earthmovers and 25 dumpers have been deployed to remove the mining waste and 40 per cent of the work has already been completed, said Ajay Singh Gurjar -- a junior engineer of the water resources department, which is executing the cleanup drive.

The work is now stopped for the monsoon but it will be com-

pleted by November, he added. Research scholar Suman Sharma, who is pursuing a PhD on the water crisis in the Kota-Bundi region, said it was a rare example of a "buried river" being revived by an environ-

mentalist's passion.

Rivers are living entities and this fact is being affirmed by the courts, Sharma added.

Shivaji statue unveiled last year by PM collapses

Opposition slams govt for poor quality of work

Mumbai, August 26: A statue of Maratha King Chhatrapati Shivaji Maharaj, unveiled by Prime Minister Narendra Modi at a fort in Maharashtra's Sindhudurg district, collapsed Monday, an official said.

Following the incident, the Opposition parties have slammed the state government, alleging it had paid little attention to the quality of work. A 35-foot statue of Chhatrapati Shivaji Maharaj collapsed around 1 pm at Rajkot Fort in Malvan, the official said.

Experts will ascertain the exact cause of the collapse, but the district has witnessed heavy rains and gusty winds in the last two to three days, he said.

Senior officials of the police and district administration reached the site to take stock of the situation, and the damage is being examined, he said.PM Modi un-

veiled the statue December 4 last year on the occasion of Navy Day. He also participated in the celebrations at the fort.

NCP (SP) state president and former minister Jayant Patil said, "The state government is responsible for the collapse, as it did not take proper care. The government paid little attention to the quality of work. It only focused on conducting an event where Prime Minister Narendra Modi was invited to unveil the statue. This Maharashtra government only issues new tenders, accepts commissions and gives contracts accordingly."

Shiv Sena (UBT) MLA Vaibhav Naik also criticised the state government for the alleged poor quality of the work.

"The state government may try to evade responsibility. People responsible for the construction and erection of the statue must be probed thoroughly," he said.

States, UTs directed to give complete info on open prisons

Semi-open or open prisons allow convicts to work outside the premises during the day to earn a livelihood and return in the evening

New Delhi, August 26: The Supreme Court has directed several states and Union Territories (UTs) to provide complete information with regard to the functioning of open prisons within four weeks.

Semi-open or open prisons allow convicts to work outside the premises during the day to earn a livelihood and return in the evening. The concept was introduced to assimilate the convicts with society and reduce psychological pressure as they faced difficulties in leading normal lives outside.

A bench of Justices BR Gavai and KV Viswanathan was informed by senior advocate K Parameshwar, who is assisting the top court as an amicus curiae in a matter related to congestion in jails, that several states and UTs have not yet filed their responses.

The bench noted that states and UTs like Delhi, Himachal Pradesh, Madhya Pradesh and Punjab have not yet submitted the qualitative/quantitative charts despite circulation of a questionnaire seeking information in respect of the status and functioning of open correctional institutions and



whether such institutions exist

within their jurisdiction. 'We, therefore, direct that all

within a period of four weeks from today," the bench said in

the States/Union Territories, which have not yet filed their response, to file complete response its order passed August 20. It said the states and UTs,

which have not given complete information, shall also ensure compliance within four weeks.

'We further clarify that if any of the state governments or Union Territories do not respond in terms of the orders passed by this court, we will be compelled to direct the presence of the chief secretary of the

states/Union Territories concerned before this court." the bench said and posted the matter for further consideration after four weeks.

The apex court noted that July 15, it had directed the chief secretaries of various states and UTs to submit their responses on the issue of open jails.

The amicus told the bench that states and UTs of Gujarat, Haryana, Jammu and Kashmir, Maharashtra, Manipur, Nagaland, Telangana, Uttar Pradesh, Dadra and Nagar Haveli, Daman and Diu, Lakshadweep, Puducherry and Ladakh, have not filed their responses yet. While hearing the matter May 9, the apex court had observed that establishing open jails can be one of the solutions to overcrowding and also addressing the issue of rehabilitation of prisoners

In its May 17 order, the bench had noted the submission of the amicus that a model draft manual has been prepared by the Union of India where the nomenclature 'open correctional institutions' is used for such facilities

Coast Guard rescues 11 crew members



25 Naxalites surrender

Woman, 2 children electrocuted

LOCALS WELCOME DECISION AS FULFILMENT OF LONG PENDING DEMAND

Leh/New Delhi, August 26: Union Home Minister Amit Shah announced Monday the creation of five new districts in Ladakh, raising their number to seven in a decision welcomed by local people as fulfilment of their long-pending demand.

The new districts are: Zanskar, Drass, Sham, Nubra, and Changthang.

However, the Leh Apex Body, which along with the Kargil Democratic Alliance (KDA) is fighting for their four major demands including granting of statehood and extension of sixth schedule of the Constitution, said they will continue their peaceful struggle.

In a post on X, Shah said the Union Home Ministry has decided to create the five new districts in pursuit of Prime Minister Narendra Modi's vision to build a developed and prosperous Ladakh.

'The new districts, namely Zanskar, Drass, Sham, Nubra and Changthang, will take the benefits meant for the people to their doorstep by bolstering governance in every nook and cranny," he said.

Leh and Kargil were the only

two districts in Ladakh, the largest union territory in terms of area but the second least populous. It has an expanse of 86,904 square kilometers bordering China and Pakistan, with a population of 2.74 lakh according to the 2011 census.

The home minister said the Modi government is committed to creating abundant opportunities for the people of Ladakh.

Ladakh was carved out of the erstwhile state of Jammu and Kashmir and declared a UT after the state was divided into two UTs August 5, 2019.

On that day five years ago, Article 370, which gave special status to the erstwhile state, was also abrogated. Being a UT, Ladakh comes under the direct

administrative control of the union home ministry.

Prime Minister Modi hailed the creation of the new districts as a step towards better governance and prosperity.

Zanskar, Drass, Sham, Nubra, and Changthang will now receive more focused attention, bringing services and opportunities even closer to people, he said, congratulating them.

He said on X, "Creation of five new districts in Ladakh is a step towards better governance and prosperity.'

WCD slams WB govt over delay in enacting women's safety measures

New Delhi, August 26: Lambasting the West Bengal government for its alleged failure to implement crucial safety measures for women and girls, Women and Child Development Minister Annapurna Devi has said the state has not taken any step to start the remaining 11 fast track special courts in spite of a pendency of 48,600 rape and POCSO cases

In a letter to Chief Minister Mamata Banerjee, Devi criticized the West Bengal government for failing to implement key emergency helplines such as the Women Helpline (WHL), **Emergency Response Support** System (ERSS) and Child Helpline.

Asserting these services are essential for providing immediate assistance to victims of violence, she said the state has yet not integrated them despite multiple reminders from the Central government.

This lapse. Devi argued, deprives the women and children in West Bengal of critical support in times of distress.

In a pointed rebuke, she highlighted the state's inability to operationalise the Fast Track Special Courts (FTSCs) allocated to it under a centrally sponsored scheme despite a significant backlog of cases related to sexual offenses.

In the letter dated August 25, the minister emphasized the urgency of implementing stringent legal frameworks and ju-



dicial processes to ensure the safety and security of the women and children in West Bengal.

The FTSC scheme, launched in October 2019, was designed to expedite the trial and disposal of pending cases related to rape and the Protection of Children from Sexual Offenses (POCSO)

Under this scheme, the Central government allocated 123 FTSCs to West Bengal, including 20 exclusive POCSO courts and 103 combined courts for both rape and POCSO cases.

However, as of mid-June 2023, none of these courts had been made operational, the minister

Devi pointed out that despite the state government's commitment in June 2023 to start seven FTSCs, only six exclusive POCSO courts had been operationalized by June 30, 2024.

This delay persists despite a backlog of 48,600 rape and POCSO cases in the state, she said. The minister expressed grave concern over the state government's inaction in activating the remaining 11 FTSCs.

The legislation prescribes severe punishments, including rigorous imprisonment, for offenses such as rape, gang rape and sexual abuse against



Local emissions in NCAP cities to rise by at least 11% by 2030

New Delhi, August 26: Local emissions in most cities covered

under the National Clean Air Programme (NCAP) are projected to rise by at least 11 per cent by 2030 compared to 2019 levels, according to a new study.

The study, conducted by the think tank Center for Study of Science, Technology and Policy (CSTEP), examined 76 out of the total 131 NCAP cities over a period of 2.5 years.

The findings revealed that only 8 of the 76 cities are likely to achieve a 40 per cent reduction in four major pollutants -- PM10, PM2.5, sulphur dioxide, and nitrogen oxides -- by 2030, compared to 2019 levels.

"Our study shows that most cities covered under the NCAP will not be able to achieve a 40 per cent reduction in local emis-

sions even by 2030," said Anirban Banerjee, project lead at CSTEP. Local emissions are expected

to increase by 11 to 45 per cent in the studied cities by 2030, relative to 2019 levels, significantly worsening pollution, the study said.

The study estimated the share of the four major pollutants for the base year 2019 and projected their contributions from different sources until 2030. These outcomes were validated against transport and domestic fuel consumption surveys conducted in over 70 percent of the studied


The findings suggest that without targeted interventions, local

emissions will likely rise by 2030. The study recommends prioritising targeted interventions for major emission sources such as industries, transportation, construction, and open burning in these cities to meet NCAP

targets and achieve cleaner air. A portal visualising the study's findings will be launched Wednesday at the sixth edition of the India Clean Air Summit (ICAS), a premier conference on air pollution organised by CSTEP, taking place from August 26 - 30

Launched in 2019, the NCAP is India's first national initiative to set clean air targets, aiming for a 20-30 per cent reduction in PM10 pollution by 2024, with 2017 as the base year. The revised target is a 40 per centreduction by 2026, using 2019-20

as the base year.

Malaysian naval attack ship sinks

Kuala Lumpur: Malaysian authorities were working Monday to salvage a 45-yearold fast attack naval ship that sank after it struck an unknown underwater object. The navy said in a statement that a leak was first detected in the engine room of the KD Pendekar Sunday, which quickly flooded the vessel. The crew failed to fix the hole and the 260-ton shin sank underwater hours later off the coast of southern Johor state, it said. All 39 crew members were evacuated safely, with no injuries.

China violates Japan airspace

Tokyo: Japan scrambled fighter jets after a Chinese military aircraft "violated" Japanese airspace, the defence ministry said Monday, A Chinese aircraft was "confirmed to have violated the territorial airspace off the Danjo Islands in Nagasaki Prefecture," the ministry said in a statement, adding it had launched fighter jets on an emergency basis". The "Y-9 intelligencegathering" aircraft entered Japanese airspace at 11:29 am for around two minutes, the ministry added. Local media including public broadcaster NHK said the incident marked the first incursion by the Chinese military's aircraft into Japan's airspace.

More than 73 killed after militant attacks in Pakistan's province

Quetta, August 26: More than 73 people were killed in Pakistan's province of Balochistan when separatist militants attacked police stations, railway lines and highways and security forces launched retaliatory operations, officials said Monday.

The assaults were the most widespread in years by ethnic militants fighting a decades-long insurgency to win secession of the resource-rich southwestern province, home to major Chinaled projects such as a strategic port and gold and copper mine.

"These attacks are a well thought out plan to create anarchy in Pakistan," Interior Minister Mohsin Nagyi said in a statement, adding that security forces had killed 12 militants in operations after the attacks Sunday and Monday.

Pakistan's military said 14 soldiers and police, and 21 militants, were killed in fighting after the largest of the attacks, which targeted buses and trucks on a major highway.

Pak court acquits man charged with cybercrime

Lahore, August 26: A Pakistani court Monday acquitted a local man of cybercrime offences involving the spread of fake online information which fuelled riots in Britain, his lawyer said.

The riots began after false information circulated online wrongly blaming an Islamist migrant for the killing of three young girls in a knife attack in the northern English town of Southport in late July.

Farhan Asif, who ran a web publication, was arrested in the eastern Pakistani city of Lahore and charged last week by the country's Federal Investigation Agency (FIA).

'He has been absolved in the investigation," his lawyer Rana Rizwan Akhtar told Reuters TV, saying the investigation agency could not find any basis to prove that his client was involved in any illegal activity.

After a hearing Monday, the judge ordered the release of Asif, who walked free. He told the judge that he deleted his post on social media only six hours after realizing that it was not correct.

Asif had provided the agency with all of his social media accounts and access to all of his devices, he said.





RBI to launch platform for rural, small biz lending

Bangalore, August 26: Buoyed by the success of digitalisation of financial services, the Reserve Bank will be launching Unified Lending Interface (ULI), a platform to ensure frictionless flow of credit, especially for smaller and rural borrowers.

Last year, the Reserve Bank had launched a pilot of a technology platform which enables frictionless credit in two states.

"From now on, we propose to call it (platform) the Unified Lending Interface (ULI). This platform facilitates seamless and consent-based flow of digital information, including even land records of various states, from multiple data service providers to lenders," said RBI Governor Shaktikanta Das at the RBI@90 Global Conference on 'Digital Public Infrastructure and Emerging Technologies' here.

He emphasised that the 'new trinity' of JAM-UPI-ULI will be a revolutionary step forward in India's digital infrastructure

In the inaugural speech, Das said Unified Payments Interface or UPI, a real-time payment system launched in India in April 2016 by the National Payments Corporation of India (NPCI), has played a significant role in the growth of retail digital payments in India.

NPCI was promoted by banks under the guidance of the Reserve Bank.

While initial participants on the UPI platform were banks, non-bank third party app providers and use of QR codes have all combined in popular-

It has since emerged as a ro-



bust, cost-effective and portable retail payment system and is attracting active interest across the globe, Das said.

He said the ULI will cut the time taken for credit appraisal, especially for smaller and rural borrowers. The ULI architecture has common and standardised APIs, designed for a 'plug and play' approach to ensure digital access to information from diverse sources.

This reduces the complexity of multiple technical integrations and enables borrowers to get the benefit of seamless delivery of credit, quicker turnaround time without requiring extensive documentation, he

Das said by digitising access to the customer's financial and non-financial data that otherwise resided in disparate silos, ULI is expected to cater to large unmet demand for credit across various sectors, particularly for agricultural and MSME bor-

"Based on our experience from the pilot project, a nationwide launch of the ULI will be done in due course. Just like UPI trans-

formed the payments ecosystem, we expect that ULI will play a similar role in transforming the lending space in India," Das said.

The Governor further said that ideally, while the legacy payment systems should be able to connect to each other and so should the Central Bank Digital Currency (CBDC) systems, one country's legacy system should also be interoperable with another country's CBDC.

Actual implementation of interoperability would pose challenges and may involve certain trade-offs, he said.

Technical barriers may be surmounted by using common (international) technical standards. Further, the governance structure or management framework for long-term sustainability would also need to be finalised. Das said.

He said the UPI system has the potential to evolve into a cheaper and quicker alternative to the available channels of crossborder remittances.

A beginning can be made with small value personal remittances as it can be quickly implemented. the Governor added

FSSAI withdraws advisory on removal of 'A1', 'A2' milk claims

New Delhi, August 26: Food safety regulator FSSAI Monday withdrew its recent advisory wherein food businesses were directed to remove claims of 'A1' and 'A2' types of milk and milk products from packaging.

The Food Safety and Standards Authority of India (FSSAI) said the advisory has been withdrawn to carry out further consultations with stakeholders. It would imply that food business operators (FBOs) can continue to sell and market their products with claims of 'A1' and "A2' types of

A1 and A2 milk differ in their beta-casein protein composition, which varies based on cow breed.

In a fresh advisory issued Monday, the regulator said, "the advisory dated August 21, 2024...stands withdrawn for further consultation and engage ment with the stakeholders".

The FSSAI, in its advisory dated August 21, had asked FBOs to remove claims of 'A1 and A2 from their products. E-commerce platforms were also told to remove these claims from products and websites imme-

The regulator had said that the claims of 'A1' and 'A2' types of milk and milk products do not conform with the Food Safety and Standards Act, 2006.

After examination, the FSSAI had found that A1 and A2 differentiation is linked to the structure of beta-casein protein in milk. However, current FSSAI regulations do not recog nise this differentiation.

In the August 21 advisory, FBOs were also asked to exhaust pre-printed labels within six months, with no further extensions to be granted

Over 23L govt employees under NPS get option to choose UPS



New Delhi, August 26: The just-announced Unified Pension Scheme for central government employees will be available only for those who are currently subscribers of the New Pension Scheme (NPS), including re-

The new scheme guarantees employees 50 per cent of their average basic pay over the last 12 months before retirement as a pension for a minimum qualifying service of 25 years against a market returns linked payout under the NPS

According to the scheme approved by the Union Cabinet, the pension will be proportionate for a lesser service period of up to a minimum of 10 years. Also, assured pension of ₹10,000 per month on superannuation after a minimum of 10 years of service.

The scheme has been brought out to address the concerns of government employees over NPS, which came into effect from January 1, 2004.

Under the old pension scheme (OPS), effective before January 2004, employees got 50 per cent of their last drawn basic pay as

Unlike the old pension scheme, UPS is contributory in nature, wherein employees will be required to contribute 10 per cent

of their basic salary and dearness allowance while the employer's contribution (the central government) will be 18.5 per cent.

Under the NPS, the employer contribution is 14 per cent, and the employee contribution is 10 per cent. However, the eventual payout depends on the market returns on that corpus, mostly invested in government debt.

Employees, under the OPS, were not required to make any contribution. They, however, contributed to the General Provident Fund (GPF). The accumulated amount, along with interest, was paid to the employee at the time of retirement.

As the NPS was less attractive than the OPS several non-BJP-ruled states decided to go back to the old pension scheme which offered a DA-linked benefit. This prompted the Centre to constitute a committee in April 2023, under former Finance Secretary and now Cabinet Secretary-designate TV Somanathan to suggest improvement in the NPS archi-

Fulfilling the long pending demands of government employees ahead of assembly elections in Haryana and Jammu and Kashmir, the Union Cabinet on August 24 approved the UPS, which will provide assured pension to 23 lakh eligible central government employees.

Ql GDP growth to decline to 7.1%: SBI economists

Mumbai, August 26: Economists at the country's largest lender SBI Monday joined other watchers forecasting a slip in the economic growth and estimated India's real GDP growth to come at 7.1 per cent for the June quarter.

The economists said the growth in gross value added (GVA) will fall below 7 per cent to 6.7-6.8 per cent for the April-June period this fiscal when compared to the year-ago period. "As per our 'Nowcasting Model', the forecasted GDP growth for Q1 FY25 would be 7.0-7.1 per cent, and GVA is at 6.7-6.8 per cent with a downward bias," the economists said.

It can be noted that the real GDP growth had come at 7.8 per cent in the June quarter last year and the preceding March quarter. A slew of analysts have been pointing to a moderation in economic activity in the June quarter, mainly driven by softer manufacturing and lower government spending due to the general elections

The report also said that given the uncertain global growth outlook and the softening inflation, there is a space for monetary policy easing.

The SBI economists said its growth estimates are based on

41 lead indicators, and pointed to a moderation in sales growth and an inching up in staffing costs for manufacturing companies. "Against this backdrop. profit margins have declined, and this will pull down manufacturing growth," it added.

If one were to exclude the banking, finance and insurance companies, corporates reported only 5 per cent revenue growth and a degrowth of 1 per cent in operating profits in Q1 FY25, it said. SBI economists have, however, retained their 7.5 per cent growth estimate for the fiscal year 2024-25, which is higher than the 7.2 per cent made by

The report said the global economic outlook remains uncertain, and the persistent geopolitical tensions, rekindled fears of a potential recession on signs of weaker than expected labour market outcomes in key economies and financial market volatility in response to monetary policy divergence cast a shadow on prospects.

On the positive side for India, the South West monsoon picked up from early July, closing the deficit, it said, noting that as of August 25, the cumulative rainfall was 5 per cent above the LPA (long period average) against 7 per cent below the LPA during the same period last year.

Indore, August 26: WFI President Sanjay Singh Monday said India have the potential to win four to five medals in women's wrestling at the 2028 Olympic Games but for that to happen "a couple of institu-tions" will have to stop interfering in day-to-day functioning of the national federation.

The Wrestling Federation of India (WFI) remains suspended by the Sports Ministry even as world governing body UWW had lifted its suspension in February following conduct of its election.

The ministry had suspended WFI December 24, three days after it held elections where Sanjay Singh was elected the new President.

Ministry's action came in the wake of WFI's announcement of hosting U-15 and U-20 Nationals, hours after the

Ministry said the announcement was against the rules since a 15-day notice was required so that players could prepare.

WFI had maintained that young wrestlers would have lost one year if it waited for 15 days since 2023 season would have finished by then.

IOA, on being asked by the ministry, had formed an ad-hoc panel to run the federation but dissolved the panel recently. However, the ministry is vet to lift its suspension

"If WFI is allowed to do its work independently and a couple of institutions stop interfering in our functioning, we can get the country four to five medals in women's wrestling in the next Olympics," Sanjay Singh told PTI.

Sanjay Singh also urged Vinesh Phogat to reconsider her retirement decision.

Vinesh announced her retirement from the sport after missing out on a medal at the Paris Olympics. She was disqualified after weighing 100 grams more before the women's 50kg final.

"If Vinesh Phogat has to play pure wrestling, she should reconsider her decision of retirement as the new generation of women wrestlers will get inspiration from her and move forward. The way she is sharing a political platform nowadays, if she has to do politics (in future), then she should not do politics in wrestling," he said.

On speculation that Phogat might enter the political arena, Singh refused to comment saying it was a personal matter of the 30-year-old wrestler. He said he would extend full support to Phogat if she returns to competitive wrestling.

Singh also said that the movement of the country's wrestlers in 2023 has given the WFI a 'very big lesson".

The agitation was launched against the then WFI president Brij Bhushan Sharan Singh in an alleged sexual harassment

"We were expecting Indian wrestlers to win six medals in the Paris Olympics but wrestling activities were stopped for 18 months under the conspiracy of anti-national forces. Due to this movement, the country could get only one medal in the Olympics," he said.

The WFI president's comment has two days after India's U17 women team won the World title. riding on a phenomenal performance in Amman where five Indian wrestlers emerged world champions apart from winning a silver and two bronze

"I want to keep wrestling and politics separate. So I don't want to name anyone who started this movement, but it is because of politics entering wrestling that this fate has happened to wrestling at the Paris Olympics," he said.

He also informed that WFI is considering opening a wrestling academy in Ujjain, the religious city of Madhya Pradesh.

The state Chief Minister Mohan Yadav is the president of the state wrestling association. "Initial discussion with the chief minister regarding the plan to open a wrestling academy in Ujjain is already underway," he added.
