Bonds: Extortion charge against Sitharaman

Bangalore, Sept 28: A case was registered Saturday against Union Finance Minister Nirmala Sitharaman and others on the directions of a court here, following a complaint relating to the nowscrapped electoral bonds scheme.

According to police, an FIR was registered under IPC sections 384 (punishment for extortion), 120B (criminal conspiracy) and 34 (acts done by several persons in furtherance of common intention) against Union Minister Nirmala Sitharaman, ED officials, officebearers of the BJP based on the order of a special court.

The complaint was lodged by Adarsh R Iyer, Co-President of Janaadhikaara Sangharsha Parishath alleging that the accused "committed extortion under the guise and garb of electoral bonds and benefitted to the tune of 8,000 and more crore of rupees.

The complainant further alleged that Sitharaman, through the clandestine aid and support of ED officials, facilitated extortion of thousands of crores of rupees for the benefit of

"The entire extortion

electoral bonds has been orchestrated hand in glove with officials of BJP at various levels."

The Supreme Court in February had struck down the electoral bond scheme, saying it violates the right to information and the freedom of speech and expression under the Constitution.

Karnataka Chief Minister Siddaramiah, whose resignation is sought by the opposition BJP as an FIR was registered against him over the Mysuru **Urban Development Authority** site allotment case, said: "According to BJP leaders' argument, Nirmala Sitharaman should resign now, right?" Responding to this, JD(S) leader and Union Minister HD Kumaraswamy, said: "Why should Nirmala Sitharaman resign? Has electoral bond funds gone to Nirmala Sitharaman's personal account?"



Hezbollah chief Nasrallah killed ASSOCIATED PRESS airstrike was based on years of

Beirut, Sept 28: Lebanon's Hezbollah group confirmed Saturday that its leader and one of its founders, Hassan Nasrallah. was killed in an Israeli airstrike in Beirut the previous day.

A statement Saturday said Jasrallah "has ioined his fel low martyrs." Hezbollah vowed to "continue the holy war against the enemy and in support of Palestine.

Nasrallah, who led Hezbollah for more than three decades, is by far the most powerful target to be killed by Israel in weeks of intensified fighting with Hezbollah. The Israeli military said it carried out a precise airstrike Friday while Hezbollah leadership met at their headquarters in Dahiyeh, south of Beirut.

Man, 4 daughters found dead in Delhi

NEW DELHI: The decomposed bodies of a 46-year-old man and his four daughters, two of them differentlyabled, have been found from their rented house here in Vasant Kunj area, police said Saturday, The deceased have been identified as Heeralal Sharma, who worked as a carpenter, and his four daughters --Neetu (26), Nikki (24), Neeru (23) and Nidhi (20). Though, the bodies did not have any injury mark, police found three packets of poison and a spoon containing a suspicious liquid from the house. Police suspect it to be a case of suicide as no evidence of any foul play has been found.

State Cabinet nod for Kamadhenu scheme

Bhubaneswar, Sept 28: Mukhyamantri Kamadhenu Yojana (MKY) was among the seven proposals approved by the state Cabinet, chaired by Chief Minister Mohan Charan Majhi, here Saturday.

Addressing media after the meeting, Law Minister Prithiviraj Harichandan said MKY will be implemented in the state for five years (FY 2024-25 to FY 2028-29) with a budgetary allocation of ₹1,423.47 crore.

"The scheme aims at increasing milk production in the state. It would benefit over 15,47,837 farmers over five years," he added. "While ₹110.23 crore has been allocated for buffalo entrepreneurship development, ₹476

Earth will have a 'mini moon' for two months an astronomer at Massachusetts

Washington, Sept 28: Earth's moon will soon have some company — a "mini moon".

The 'mini moon' is actually an asteroid about the size of a school bus at 10 metres. When it whizzes by Earth Sunday, it will be temporarily trapped by the latter's gravity and orbit the globe

- but only for about two months. The space rock — 2024 PT5 was first spotted in August by astronomers at Complutense University of Madrid using a powerful telescope located in



'This happens with some frequency, but we rarely see them because they're very small and very hard to detect," he said. "Only recently has our survey capability reached the point of spotting them routinely.'

Institute of Technology. The last

known one was detected in 2020.

The discovery by Carlos de la Fuente Marcos and Raúl de la Fuente Marcos was published by the American Astronomical Society.

This one won't be visible to the naked eye or through amateur telescopes, but it "can be observed with relatively large, research-grade telescopes," Carlos de la Fuente Marcos said in an

Binzel, who was not involved in the research, said it's not clear whether the space rock originated as an asteroid or as "a chunk of the moon that got blasted out".

The 'mini moon' will circle the globe for almost 57 days but won't complete a full orbit. It will part ways with the Earth and continue its solo trajectory through the cosmos, November 25.

The event is part of ZFT's annual fundraiser to support people living with autism spectrum disorder.

Adapted to Hindi by Farrukh Seyar and Avinash Gautam from the English play The Sunshine Boys, the drama is set in contemporary Mumbai. The Sumeet Vvas directorial delves into the world of two retired comedy geniuses who are brought together to reprise their iconic act after 12 years for the biggest festival of comedy in the country. The only problem is they can't stand each other. Will they be able to put aside their differences and create the same magic? The answer will be out October 5.

Apart from eminent actor Kumud Mishra, the D For Drama Company productions' play has Subhrajyoti Barat in the other key role.

The two also featured last year here in play Dhumrapan, another ZFT presentation.

Talking about Kumud, the actor has carved a space for himself in the Hindi film industry with his performances in Rockstar, Raanjhanaa, Sriram Badlapur, Sultan, Airlift, Rustom, Article 15, Lust Stories 2, and many others.

Similarly, Shubhrajyoti is known for The Second Best Exotic Marigold Hotel (2015), Article 15 (2019), and The Best Exotic Marigold Hotel (2011).

As per ZFT, ever since its formation in 2015, the Foundation has initiated plenty of advocacy and awareness exercises, successfully both in the state and nationally, through workshops, rallies, sporting events, art exhibitions, and specially curated inclusive events, as it moves towards its mission of raising eastern India's very first residential facility for the autism community.

The organisation also started a novel initiative called the PECS Café. PECS stands for Picture **Exchange Communication** System. It is a tool used the world over for communication, among and with those with autism spectrum disorder, PECS, however, has never been used as a tool in the employment space.

The cafe was opened last year to train adults with autism, to make muffins, cookies, pound cake, sandwiches, and lemonade from the word go. Mixing, blending, and baking were taught by Sweta Misra of Gelhi's Cakes and Bakes

The adults are now almost trained to start taking orders from a picture driven menu, execute the order, and serve the customer. This exercise would open at the CSM Technologies Campus, where 300 employees would get direct exposure with the adults with autism, learn the ways of a differently wired disposition,

transfer the much-needed awareness to those they meet in their lives.





Bhubaneswar, Sept 28: Chief Minister Mohan Charan Majhi is likely to undertake a two-day visit soon to Jharkhand where Assembly polls are due later this year, sources said Saturday.

Majhi, who heads the BJP's first government in Odisha, and is a prominent tribal

leader belonging to the Santhal community, is expected to visit the neighbouring state September 30 and October 1 and attend the 'Parivartan Yatra' of the saf-

fron party, they said.

The Odisha CM is likely to visit Jagannathpur in West Singhbhum district of Jharkhand on the first day of his visit and Kolhan in Chaibasa the next day, the sources said.

The development comes after Majhi met Assam Chief Minister Himanta Biswa Sarma, who is also BJP's co-in-charge of elections in Jharkhand

Both the CMs had a discussion at the Raj Bhavan here Friday in the presence of Odisha Governor Raghubar Das.

Meanwhile, Union Tribal Affairs Minister Jual Oram, who also hails from Odisha and is a tribal leader. Saturday visited Jharkhand and attended several programmes there. The saffron party, which is optimistic

about winning the polls in Jharkhand, has roped in several party leaders, MLAs and MPs of

BJP MP and prominent Kudumi samaj leader Mamata Mohanta has already visited the neighbouring state and is likely to go there again for the election campaign. Jharkhand shares a border with Sundargarh, Keonjhar, Mayurbhanj and Balasore districts. Defunct equipment cripples OSPCB

Bhubaneswar, Sept 28: The Odisha State Pollution Control Board (OSPCB) has been unable to carry out tests on an issue of alleged groundwater contamination by an industrial unit in Rayagada district for months

This was revealed in an affidavit filed by OSPCB with the National Green Tribunal (NGT) wherein the apex pollution watchdog of the state said that owing to the defunct Atomic Absorption Spectrophotometer (AAS) it could not carry out a crucial procedure to determine concentration of metals in a sample.

While hearing a plea filed by Nanda Jhodia and a few others alleging pollution in Rayagada district, the NGT had asked the OSPCB to check the quality of groundwater at Tikiri in Rayagada.

The OSPCB collected the water samples from Tikiri August 16, 2024 and sent it for testing to the central laboratory Bhubaneswar the next day.

'The regional officer of Rayagada has collected the samples from Lachhiguda village and sent it for analysis of parameters like pH, electrical conductivity, total suspended solids, total dissolved solids, turbidity, total alkalinity, p. Alkalinity, total hardness, calcium hard ness, magnesium hardness, nitrate, ammonical N, TKN, sulphate, phosphate, sodium, potassium, total fixed solids,



As, Cu, Cd, Cr, Pb, Ni, Zn and Fe, said the affidavit by OSPCB member secretary Kaliasam Murugesan.

The central laboratory analysed the samples for all parameters except for the presence of metals like Cu, Cd, Zn, Ni and Pb, the affidavit said. The OSPCB attributed its in-

ability to analyse the sample for metals to the defunct AAS. '...metals like Cu, Cd, Zn, Ni

and Pb are to be analysed by the

Atomic-Absorption Spectrophotometic (AAS) methods, as the rectification of the AAS has not yet completed..., Murugesan added.

The OSPCB, however, said M/s Spectrolytic Scientific India Private Limited has already been asked to do the needful so as to address the issue.

Earlier during the hearing of the case in August, the NGT had come down heavily on the OSPCB over the issue, petitioner's counsel Sankar Prasad Pani said.

"It is surprising that the State Pollution Control Board which is the Regulatory Authority armed with Environmental Scientist. Senior Environmental Scientist and Chief Environmental Scientist, does not have functional instruments," the NGT had said.

New draft guidelines on passive euthanasia released

New Delhi, Sept 28: Doctors should take a "considered decision" on withdrawal of life support in terminally ill patients on the basis of certain conditions including a documented informed refusal by the patient or their kin, according to draft guidelines by Union Health Ministry. The guidelines laid out four conditions

on passive euthanasia for taking a "considered decision in a patient's best interests, to stop or discontinue ongoing life support in a terminally ill disease that is no longer likely to benefit the patient or is likely to harm in terms of causing suffering and loss of dignity.'

The conditions are whether the individual has been declared brainstem death, if there is a medical prognostication and considered opinion that the patient's disease condition is advanced and not likely to benefit from aggressive therapeutic interventions, patient/surrogate documented informed refusal, following prognostic awareness, to continue life support and compliance with procedure prescribed by the Supreme Court.

The 'Draft Guidelines for Withdrawal of Life Support in Terminally Ill Patients, also state that doctors should take a considered decision to not start a life supporting measure in a terminally ill patient that is unlikely to benefit the patient and is likely to lead to suffering and loss of dignity. In such a case, three conditions — on whether the individual has been declared brainstem death, if there is a medical prognostication and considered opinion that the patient's disease condition is advanced and not likely to benefit from aggressive therapeutic interventions, patient/surrogate documented informed refusal, following prognostic awareness — has to be taken into account.

The Union ministry has invited feedback and suggestions from the stakeholders on the draft by October 20.

The draft guidelines have not gone down well among the members of the medical fraternity, with the IMA's national president RV Asokan stating it exposes doctors to legal scrutiny and puts them under stress. "Such clinical decisions have always been taken in good faith by doctors. The patient's relatives are explained and given all information, taken into confidence in a given case and decision is taken on merit in every single case. Putting it down in sort of guidelines and also alleging

that inappropriate decisions have been taken or they have been prolonged is misunderstanding the situation," Asokan

"First the perception and assumption that unnecessarily machines are used and lives are prolonged is wrong. It exposes the doctors to legal scruity.

"More so what is left of a doctor-patient relationship... trying to define it in four corners of black and white documentation which is legally scrutinised is nothing but exposing the doctors to further stress," he said. There are things which should be left to relatives, patients, and doctors based on science and situation. Asokan said. The Indian Medical Association, Asokan said, will study the document and submit its views seeking a revision of the draft guidelines.

Terminal illness in the draft guidelines has been defined as an irreversible or incurable condition from which death is inevitable in the foreseeable future. Severe traumatic brain injury which shows no recovery after 72 hours or more is also included.

The draft document states that many patients in the ICU are terminally ill, and not expected to benefit from life sustaining treatments (LST) that include (but are not limited to) mechanical ventilation, vasopressors, dialysis, surgical procedures, transfusions, parenteral nutrition or Extracorporeal Membrane Oxygenation.

out to the duo, they allegedly told him that he needed to invest ₹30 lakh more to withdraw the money along with the capital. "This is when the complainant realised that he had been conned," Tudu added. 5 workers injured in accident at RSP

Rourkela, Sept 28: At least five workers were injured in an accident at the Steel Melting Shop-1 (SMS-I) of Rourkela Steel Plant here Saturday, official



According to preliminary information, steel was being made in the converters of the SMS-I.

"As per regular practice after tapping steel from the converter. slag splashing is done to nourish the converter lining. However, at about 8.45am Saturday when slag splashing

was carried out, a jam stuck up in the movable hood of the converter. Suddenly the slag fell into the converter thereby resulting in the splashing of residual slag," an official note issued by the RSP said.

This has caused injury to five people (four employees and one contractual labour) working in the nearby area, it said.

All of them were immediately admitted to the burn centre of Ispat General Hospital after administering first aid. The condition of all the five affected people is stable so far, the statement said.

It also said that a committee headed by a chief general manager has been formed to enquire into the cause and fix responsibility.

Nine people were arrested for allegedly being involved in a clash between two communities and attack on police personnel in Bhadrak district over the social media post, police said. A case of attack on police was registered over a complaint filed by the Puruna Bazar police ASI Manoranjan Behera.

Sources said a youth Pruthwiraj Sahani, 19, of Kharavel Nagar, who was accused of making the 'objectionable' social media post, was arrested from Bhubaneswar, Saturday. A case was registered in this connection at Puruna Bazar police station

"The man responsible for the social media post has been held," said Bhadrak DSP Anshuman Diwedi, who was among the two police personnel injured in stone pelting. Nine others were also apprehended for "rioting charges", another officer said.

Earlier in the day, the state's Home department, in a notification, said that the internet services will remain suspended in the district for 48 hours till 2am September 30 (Monday) across the district under the provisions of Section 5(2) of the Indian Telegraph Act, 1885.

The government order also mentioned that the use and access of social media platforms like WhatsApp, Facebook, X, and other medium of data services, mobile internet and broadband services will be prohibited to prevent the spread of inflammatory messages in order to restore peace and amity.

A group of people had lodged a complaint against the youth

who allegedly posted some objectionable material on social media hurting the religious sentiments of a community. The members of a particular community took out a protest rally Friday alleging delay in police ac-

tion against the accused youth. As the rally was held without prior permission of the administration, police tried to stop the rally. However, the protesters pelted stones at police injuring two policemen including a DSP. The vehicle of Bhadrak tehsildar was also damaged, they said.

A clash broke out between two communities in Santhia area of the district over a social media post Friday afternoon. The violence later spread to Dhamnagar area in the district, police said.

Meanwhile, the district administration Friday imposed prohibitory orders under Section

163 of BNSS in Puruna Bazar and Dhamnagar police station area to maintain law and order. "Any congregation, gathering, meeting, agitation are strictly prohibited in the proceeding area and violation of the same shall be viewed seriously by the district administration," the order issued by the district administration said.

At least 14 platoons of police force as well as jawans of Rapid Action Force (RAF) have been deployed in violence-hit Puruna Bazar and Dhamnagar, Bhadrak SP Varun Guntupalli said.

The suspension of internet services has disrupted works at the government offices. Similarly, protestors staged a 'rasta roko' by burning tyres and gheraoed the police station at Biju Patnaik Square in Dhamnagar, Friday evening. All business establishments at Dhamnagar town and Dobal Bazar remained shut Saturday with the roads wearing a deserted look due to plying of fewer number of vehicles.

Meanwhile, senior officials, including DIG, Bhadrak SP, and the District Collector, are monitoring the situation and holding discussions with members of the peace committee.

NHRC seeks ATR from CS on plight of Keonjhar villagers

Keonjhar, Sept 28: The National **Human Rights Commission** (NHRC) has issued notice to the Chief Secretary and sought for an Action Taken Report (ATR) on the plight and sufferings of the villagers especially from the Tribal and SC communities living in mining affected areas in Keonjhar district.

Taking cognisance of the petition filed by lawyer and human rights activist Radhakanta Tripathy, the NHRC September 19 ordered to submit the ATR within four weeks.

Sources said that the commission has received a complaint on different issues of difficulties being faced by the people in Keonjhar district due to mining. The complainant has alleged that the people indulged in mining activities as workers are forced to live in pathetic conditions.

There are no proper roads, drinking water, school and employment opportunities for them. The complainant has stated that the administration is solely responsible as no social welfare schemes are functioning in the area and the rights of the people, mostly STs, are being grossly violated. The complainant has requested the commission to intervene into the matter.

The court, after examining 12 witnesses and 18 exhibits, pronounced the verdict Saturday.

The court also ordered for ₹4 lakh compensation to the victim to be paid through the District Legal Services Authority (DLSA), Special Public Prosecutor Pranab Kumar Panda said.

Salt production on verge of extinction in Ganjam used and idle. As a result, peo-

Ganjam, Sept 28: Salt production centres at Ganjam and Humma areas in this district are on the verge of extinction due to alleged neglect and apathetic attitude of the Centre and the state governments

The centre has 1,472 acre land spread in both these areas for salt production. The Humma-Binchanapali Salt Production and Sales Cooperative (HBSPSC) alone has 729 acre land under its jurisdiction. The land is given on lease to the HBSPSC and the lease term is renewed in every 20 years. The lease was last renewed in 2011 but cultivation was not taken up by lessees. This resulted in sharp decline in salt production from this unit.



Reports said that the reason behind the decline in salt production is the disagreement between the Salt Board authorities and lessees on the formula of wages. Though Salt Board authorities and the lessees usually reach an agreement before production, both the parties did not agree on the formula on wages and this is stated to be one

of the reasons why the production came to a halt. The Salt Board authorities of the Union government and the state Industries department had constructed a salt production unit in between Humma and Suryanarayanpur. A rest house for the benefit of the salt farmers and labourers was also constructed there.

The Central Salt and Marine Chemicals Research Institute at Bhavnagar in Gujarat had identified the land for production of quality salt by the salt farmers in the state.

Meanwhile, as the authorities have stopped giving importance to salt production, the land has turned into pasture for the livestock after lying un-

ple who depended on salt production for their livelihoods have migrated to other states in search of work.

Humma, People in Lakshmipur, Jhadakuda, Suryanarayanpur, Mayurpada, Niladripur, Kantiagad, Puintola, and Binchanapali villages also do salt farming along with cul-

tivation of other crops. However, after the Centre, state government and the district administration stopped promoting salt production, people turned away from the farming and are migrating elsewhere to earn a livelihood. Locals have demanded the government to intervene and revive the salt production centre and restore its lost glory.

ext year, on 17 September, the Prime Minister turns 75. Ten days after that, the Rashtriya Swayamsevak Sangh turns 100. During the Lok Sabha campaign, BJP president JP Nadda said the party did not need the RSS as it had in the past because it was now self-sufficient. This is an unusual statement, because it assumes the two entities are totally separate. Are they?

The RSS is the only ideological fount for Hindutva. In the BJP, leaders come and go, policies come and go, the RSS remains permanently in the background as the shareholder with a controlling stake. Indeed, the RSS formed the BJP to protect it. This is according to the official history of the BJP itself, which was published by the party in 2006 as a series of six volumes

The founding of the Bharatiya Jana Sangh, the predecessor to the BJP came after an RSS rally in Delhi in December 1947 drew a large crowd and also attracted Hindu princes, businessmen and leaders of other Hindu organisations. This popularity was something that alarmed the Congress, especially Nehru, the BJP history says. The assassination of Gandhi on 30 January 1948 gave the Congress the opportunity to act. It decided to ban the RSS on 2 February, three days after Gandhi's murder.

RSS chief Golwalkar had sensed his institution would get into trouble once the details of Gandhi's assassination were out. He acted immediately. On the day of the killing, 30 January 1948, he sent telegrams to RSS branches suspending operations for thirteen days. The same day he also telegrammed Nehru, Patel and Gandhi's son Devdas with a message of condolence: "Shocked at this cruel fatal attack and tragic loss of greatest personality."

The next day Golwalkar again wrote to Nehru expressing his shock and referring to Godse as a "thoughtless perverted soul" who had "committed the heinous act of putting a sudden and ghastly end to the life of poojya Mahatmaji by the bullet." He called the killing unpardonable and an act of treason. That day he again wrote to Patel: "My heart is wrung with extreme agony. It is difficult to find words to condemn the person who committed this crime...'

None of this helped. The government notification declaring the RSS unlawful said: "The professed aims and objects of the RSS are to promote the physical, intellectual and moral well-being of the Hindus and also to foster feelings of brotherhood, love

and service amongst them ... the Government have, however, noticed with regret that in practice members of the RSS have not adhered to their professed ideals." "But now," the government said, "they have been found circulating leaflets exhorting people to resort to terrorist methods to collect firearms ... rendering it incumbent on the government to deal with the Sangh in its corpo-

rate capacity. Golwalkar was arrested on 3 February along with 20,000 swayamsevaks. The RSS says it was shocked that no political party and no political leader spoke up for it or stood in its defence. The ban remained for a little under a year and a half. It was lifted after the RSS was asked to produce a constitution. This was written up and submitted and the ban was lifted on 11 July 1949. Immediately following this, the RSS began debating entering politics in the pages of its house organ, The Organiser. It published articles from RSS workers including KR Malkani who wrote that the Sangh "must take part in politics not only to protect itself" but also 'to stop un-Bharatiya and anti-Bharatiya politics" and to "advance the cause of Bharatiyata through state machinery." For these reasons, the Sangh must "continue as an ashram for the national cultural education of the entire citizenry, but it must develop a political wing for the more effective and early achievement of its ideals.'

Malkani said the new party "will be revivalist of ancient values as t will be futuristic in its targets" and it would be told "not to depend on foreign values, attitude and manners" and that "the principle of this re-organisation in Hindustan can only be Hindutva.'

RSS worker from the Arya Samaj Balraj Madhok wrote that the Sangh "must give the lead to the country in regard to the political and economic problems of the country" because this was "vital to the very existence of the Sangh itself.'

There was little or no opposition from inside the RSS to forming a political party. Three other things catalysed the formation of the Jana Sangh/BJP. Firstly, the resignation in April 1950 of SP Mookerjee, a former Hindu Mahasabha leader, from the Nehru Cabinet, claiming Muslim appeasement by Nehru. Secondly, the death of Sardar Patel in December 1950, a year before the first general election. Thirdly, the election the same year of PD Tandon as Congress president and his being forced to resign by Nehru. Tandon was a Hindu conservative who Nehru felt (according to the BJP history) was being supported by the RSS. All three things further convinced the RSS of the need to have a conservative Hindu element in popular politics.

On 21 October, 1951, the Bharatiya Jana Sangh was launched, one year after our Prime Minister was born. Mookerjee was made its head and Golwalkar, always in the background, provided the nationwide framework for the party by deputing pracharaks to it, including Deendayal Upadhyaya from Uttar Pradesh. Today the six most senior ministers of India's Union Cabinet according to the order of precedence are Swavamsevaks.

When the BJP is unsteady during minority governments, as it was under Vajpayee and as it seems to be today, the RSS can and will assert itself. It is the mothership to which the BJP must always return.

WAKE UP TO THE TOXICITY

ong hours, stress and burnout in the work place is well known. But after two recent deaths, the work culture taking root in India needs to be urgently addressed. The case in July of a young Pune-based chartered accountant who was literally worked to death and the more recent suicide of a software engineer in Chennai after reportedly struggling with depression and work pressure for months have revealed the true nature of thriving companies. Here we see examples of businesses that present as modern-day growth beacons on the outside but on the inside are essentially sweatshops built on the hard labour of those who do not have a voice in the system - the talented youth of India.

Last week, Karthikeyan, 38, was found wrapped in livewire at their Chennai home by his wife Jayarani who had returned from a trip. He left his two children with their maternal grandparents before electrocuting himself, according to reports. Family members spoke of work pressure causing depression, for which he was under treatment for last two months. Karthikeyan was in a new job after leaving a software firm operating from Chennai, where he had worked for 15 years.

In July, Anna Sebastian Perayil, 26, collapsed after suffering what clearly is a case of toxic work culture. This is the story of the horrors of what appears to be a normalised modern-day, sleep-deprived work culture, recounted in all its shocking detail by her mother. Anna passed the CA qualifying examinations with distinction, but four months into her job with Ernst & Young, the CA collapsed.

In a letter to EY India chairman Rajiv Memani, Anna's mother Anita Augustine placed on record that everyone in the company knew that she was

being put under a manager marked for unprofessionalism. She wrote: "Anna, in fact, had received several warnings regarding her manager from colleagues: Her manager would often reschedule meetings during cricket matches and assign her work at the end of the day, adding to her stress. At an office party, a senior leader even joked that she would have a tough time working under her manager, which, unfortunately, became a reality she could not escape." This is particularly damning because it shows that EY knew, tolerated and perhaps even encouraged this manner of working, raising new questions on the lack of professionalism at a company considered one of the global "big four" of accounting firms. Should India allow these companies to have this free run? Why should the chairman not be held to account for what has gone wrong? How many inquiries are on? And what has EY done in the matter so far, other than speaking about its commitment to "nurturing a har-

monious workplace."

While EY is a global firm, India's home-grown technology sector has seen an exponential growth trajectory by rising from a very different ethos and background. It has played a key role in driving the economy forward. It held its own especially during the pandemic, delivering with speed and efficiency by turning its vast workforce into a work from home army which now worked even longer hours since they didn't have to travel to the workplace.

As life returned to normal and offices filled up, many in the IT sector have been able to keep remote work going. However, the hours employees put in have not decreased, and the stress is growing. A study earlier this year titled "Burying the Burnout: Decoding the Health Challenges of India's Tech Geniuses" found that 43% of Indian techno-professionals experience health concerns directly stemming from their work. Long working hours emerged as a significant contributor to these health issues

with over 50% tech profession als working an average of 52.5 hours per week, surpassing the national average of 46.7 hours a week (this still places India among the countries with the longest working hours). The study by 'Onsurity', an employee healthcare platform and the 'Knowledge Chamber of Commerce and Industry' says repercussions of such prolonged working hours are severe. More than half the respondents reported experiencing adverse health effects including acidity, gut problems, back and neck pain, erratic sleep cycles and eyesight related issues. Mental health concerns were also prevalent with 45% of tech professionals disclosing struggles with stress, anxiety and depression.

Such reports may not have caused much worry earlier. But not anymore as the shock and outpouring of criticism have left the government with no option other than to sit up, notice and act. The Union Labour Ministry has announced an investigation into the case of Anna Perayil and the work culture at EY that affected her health and ultimately took her life. Finance Minister Nirmala Sitharaman finds herself in a slug out with Opposition parties for suggesting that educational institutions and parents should help children build inner strength to face challenges and solve problems at work rather than

crumble under them. At a time like this, the harm caused by the words of NR Narayana Murthy, co-founder Infosys, must come to mind He had famously asked that the youth of India work 70-hour weeks to help increase national productivity. We can see that sweatshops do not increase productivity; they kill innocent

Pakistan's unsustainable debt

TO RESTORE DEBT SUSTAINABILITY, **PAKISTAN WOULD NEED TO RESTRUCTURE ITS INTERNAL AND EXTERNAL OBLIGATIONS, AS SRI LANKA IS CURRENTLY DOING**

n July, Pakistan reached a vestment, and GDP growth. High vet another attempt to kick-start economic growth and development as the country lurches from crisis to crisis. But the new IMF programme, which will likely be finalised once Pakistan secures "adequate" assurances from major creditors that its outstanding loans will be rolled over. fails to address a much more fundamental problem: the country's unsustainable debt.

Interest payments on public debt consumed an estimated 68% of Pakistan's revenue in 2022-23. and its debt-to-GDP ratio was more than 80%, compared to less than 40% in Bangladesh, which gained independence from Pakistan in 1971. The IMF estimates the country's total externalfinancing needs will total roughly \$128 billion over the next five years, with every year's needs exceeding even optimistic forecasts of its foreign reserves. To restore debt sustainability. Pakistan would need to restructure its internal and external obligations,

as Sri Lanka is currently doing. Pakistan's deep-seated problems, including entrenched business elites, a persistent democracy deficit, and the military's outsize economic role, have undermined market credibility, in-

staff-level agreement with the levels of non-transparent pro-⚠ International Monetary Fund tection have resulted in stagon a record 25th programme, in nant exports – \$35.2 billion in mestic debt accounts for the bulk 2023, compared to Bangladesh's \$57.6 billion - and recurrent foreign-exchange crises. Investment spending amounted to only 12% of GDP in 2023, compared to 31% in Bangladesh and neighbouring India, and GDP per capita was 56% of Bangladesh's.

The current crisis reflects these underlying problems. Accumulated economic imbalances, both fiscal and external, fueled inflation and contributed to rising debt levels in 2022, with massive floods only exacerbating the situation.

Addressing these problems requires debt restructuring. A World Bank study of 177 sovereign external and domestic debt defaults found that five years after successful defaults, governments had reduced their debtto-GDP ratio by 24-34 percentage points, and effective interest rates on government debt had fallen by as much as two percentage points. Consider Sri Lanka's gradual return to positive growth and increased market optimism after defaulting in April 2022: its ten-year government bond yield was 13.3% on August 30, 2024, compared to 32% in November 2022.

To be sure, debt restructuring

is never easy, and Pakistan will confront two major challenges if it chooses this route. First, doof the government's obligations. equivalent to 46% of GDP in 2023, whereas external debt was 29% of GDP (excluding IMF obligations and debt guarantees). Any meaningful restructuring would thus require domestic debt holders-mainly local banks-to take a haircut, which could pose political problems and raise concerns about financial stability. Fortunately, local banks' high profitability provides some room for maneuver.

Second, Pakistan's biggest creditor is China, which holds more than 28% of the country's total external public debt (even more than the World Bank). Given that China has proven to be a reluctant participant in sovereigndebt restructurings, this could

be a significant impediment. The Pakistani government now appears to recognise that it has a debt problem, even as it fails to acknowledge the severity of the situation. Prime Minister Shehbaz Sharif recently wrote to China requesting a debt reprofiling, which would involve extending the maturity period of existing debt and reducing interest rates.

But the proposed reprofiling would hardly make a dent in Pakistan's external-financing

needs, because it would address only the debt owed to Chinese power producers. Moreover, each energy project could be negotiated separately, which would further prolong a notoriously protracted process. In fact, there is a good chance that China will deny Pakistan's request, as it has shown a strong preference for fair burden-sharing among all creditors.

Rather than delay the reckoning, Pakistan should overcome its fears and ask the IMF to help prepare an orderly debtrestructuring programme. To set itself on the road toward sustained growth, the government must be willing to implement fundamental reforms such as raising taxes, renouncing the anti-export bias in its trade policies, and improving public-expenditure management. This will require overcoming the resistance of corporate leaders.

This path is hard and long. But the alternative is worse: a possible disorderly debt default, and continued trips to China, Saudi Arabia, the UAE, and the US seeking bailouts, would condemn Pakistan's economy to years of slow and volatile growth, performing well below its potential.

MahaYuti, MVA set to play on Waqf Bill issue

Mumbai, Sept 28: The MahaYuti and Maha Vikas Aghadi, which have geared up for the Assembly elections, have hinted that the Wagf (Amendment) Bill, which is currently referred to the joint parliamentary committee, is a key campaign issue.

The battle lines are drawn as the MahaYuti comprising BJP, Shiv Sena and NCP plan to corner the Maha Vikas Aghadi con sisting of Congress, NCP(SP) and Shiv Sena(UBT) on this issue accusing them of playing appeasement politics. On its part, the MVA has proposed to take on the BJP in particular and the MahaYuti in general for targeting and suppressing Muslims and minorities for their political gains.

Congress has gone a step further saying that its opposition to the Waqf (Amendment) Bill will be included in the poll manifesto assuring that Waqf property won't be brought under the government control as presently proposed through the district

According to the political observers, there are about 100 of the total 288 Assembly constituencies where Muslims and minorities are one of the major deciding factors

A veteran BJP leader and state Deputy Chief Minister Devendra Fadnavis has already got the ball rolling by accusing the Congress party of opposing the



Bill as it does not want transparency and is only interested in grabbing the land of Waqf Boards. He also cited many examples of land grabbing especially by Congress members durthe Congress-led governments. Fadnavis' move to target Congress and allies will be further played up as the campaign gathers momentum. senting them when it mattered. By doing this, the BJP wants to further strengthen its pro-Hindutva constituency.

The Eknath Shinde-led Shiv Sena has echoed BJP's views saying that Shiv Sena (UBT) has already abandoned Hindutva and their stand on Waqf Board exposes its ideological confusion and selfish politics.

Shiv Sena MP Shrikant Shinde has been more vocal in criticis-

ing Shiv Sena(UBT) for ditching the Muslim community after it voted in its support during general elections. He has also dropped sufficient hints that his party will step up attacks against the Shiv Sena(UBT) for seeking the votes of a particular community during the Lok Sabha elections only to avoid repre-

However, Shiv Sena UBT chief Uddhav Thackeray, who was accused by BJP and Muslim organisations of remaining absent during the Waqf Bill debate in Parliament, has shot back and announced that the party will not let anyone touch the properties of the Waqf Board or any temple or other religious property at any cost. He also guestioned the BJP for not tabling

the Bill when it had a roaring majority in the Lok Sabha.

Thackeray has revealed his plan to corner the BJP on this issue as he did during the Lok Sabha elections over the change in the Constitution. Thackeray has also indicated that he has not left brand Hindutya but his party's Hindutva is "inclusive" which does not create religious discord or set fire to relations between two communities.

NCP(SP) chief Sharad Pawar, who has been attacking the BJF for targeting Muslims and minorities, has made it clear that his party would not tolerate the misappropriation of religious property.

The Maharashtra Congress Working President and former Minister Naseem Khan claimed

that the party is strongly opposed to the Waqf Bill saying that it was not just an issue of Waqf Board properties but also temples and other religious places. He pointed out that Congress has objected to the state government's mediation through district collector for control of Waqf properties saying that it was to suppress Muslims in particular.

The Samajwadi Party, which is a part of MVA in the state, has expressed serious displeasure over the BJP-led government's timing to table the Bill. The SP legislator Rais Shaikh said it was part of a larger design of BJP to malign, offend and suppress the minorities and it was a clear violation of Articles 14, 15 and 25. He hoped that if the BJP goes on flagging off this issue, it will unite anti-BJP votes and strengthen the purpose of the INDIA Bloc.

The observers say at a time when MahaYuti is stepping up outreach with the voters by promoting welfare and development schemes, the Waqf Amendment Bill will be projected skilfully to further divide Muslims against MVA and Thackeray in particular. On the other hand, the MVA will further attack the BJP and MahaYuti on the Waqf Bill issue saying that despite the lack of a majority in Parliament BJP will continue to take its agenda of Constitution change forward by targeting minorities.

High alert in Mumbai after intel tip-off

Mumbai, Sept 28: The Mumbai Police have beefed up security in and around the city especially at crowded and sensitive places in view of possible security threats, tipped off by central intelligence agencies, official sources said here Saturday.

The police have been directed to maintain a strict vigil, particularly in public places and hotspots, religious or tourist places and other important locations, besides tabs on vehicular movements.

Besides, mock drills are being conducted - including one at a minority-dominated location in south Mumbai Friday - and police deployment has been increased at some important locations and public places including beaches

The directives come ahead of the upcoming Navratri-Durga Puja festivals, followed by Diwali and the likelihood of Maharashtra Assembly elections being announced soon.

Major religious places including temples have been advised to increase their internal and external security detail, while Zonal Deputy Commissioners of Police have been asked to keep an eye on their jurisdictions for any suspicious activities.

PLANETS, PERIODIC TABLE AND NOBLE THOUGHTS MSRTC bus draws students in droves

Chhatrapati Sambhajinagar, **Sept 28:** A state transport bus in Maharashtra's Beed district has become a huge draw among students for its education-themed interiors after its driver and conductor took it upon themselves to make the ride fun-filled and informative.

From outside, the Maharashtra Road Transport Corporation (MSRTC) bus appears no different from the thousands of similar passenger carriers, with a white-orange colour scheme, plying across the state.

But the state transport bus turns vibrant with an array of images and messages pasted on the roof and side walls resem bling a mobile classroom inside.

"Students love what we have done to the interiors of the bus In fact, more students are now travelling on our bus," conductor Vaishali Mule told PTI over the phone Friday. The bus covers a distance of 200 km daily, both ways, to pick up students from their respective villages and drop them back from schools on the Beed-Nalwandi route.

Mule said she and her driver colleague Siraj Pathan have spent ₹35,000 from their own pockets to deck out the bus with educational materials, visuals concerning personalities like Chhatrapati Shahu Maharaj, Swami Vivekananda and Dr APJ Abdul Kalam and messages imparting values.



"Most of the students using our bus are children of labourers engaged in sugarcane cutting. These families didn't bother much about sending their kids to schools. We think our initiative has changed that as more students, including girls, are going to school," she said.

While bright images of planets in the solar system have been plastered on the roof, the bus also has a periodic table and photos and information about yoga asanas (poses), she said. The bus has become a hit among students, she added.

"Students of Vishwanath School in Wangi and Sangameshwar Vidyalaya at Nalwandi travel on our bus. Our seniors Ajay More, Shivraj Karad, Nilesh Pawar helped us in this project," Mule said. Divisional Transport

Superintendent of Beed Shivraj Karad said the only aim of the project is to encourage families to send their children to school.

"The driver and conductor of the bus took the initiative and we supported them. The number of students travelling by this bus has risen to 290 from 200 in a year.

Flood alert in Bihar, lakhs hit in 12 districts

Patna, Sept 28: The Bihar government has sounded an alert for floods along swollen rivers such as Kosi, Gandak and Ganga in northern and central parts of the state following the release of water from Valmikinagar and Birpur barrages Saturday, a senior official said.

The development may aggravate the condition of over 13.5 lakh people in 12 districts, who were already affected by inundation following heavy rain.

A total of 5.31 lakh cusecs of water was released from Birpur Barrage on Kosi River till 2pm, the highest in 56 years, said Santosh Kumar Mall, Principal Secretary of the state Water Resources Department. He told PTI that all safety

measures are being ensured for securing the embankments. The last time the maximum water which was discharged from this barrage was 7.88 lakh cusecs of water in 1968

Similarly, 4.49 lakh cusecs of water was released from Valmikinagar Barrage till 2pm. This is the highest water discharged from this barrage after 6.39 lakh cusecs released in 2003.

The water level of several rivers-Gandak, Kosi, Bagmati Burhi Gandak, Kamla Balan and Mahananda and the Ganga-- has been rising across the state, following continuous rainfall over the past two-three days.

"Incessant rainfall in the catchment areas of Nepal has also

led to rivers touching or flowing above the danger level at several places in the bordering districts," the senior official said.

Following the heavy discharge of water from these two barrages, the excess river water entered low-lying areas of West and East Champaran districts,

officials said. An alert has already been sounded for several districts of Bihar as the IMD predicted heavy rain and warned of flash flood

risk in parts of the state. Districts such as West and East Champaran, Sitamarhi, Sheohar, Muzaffarpur, Gopalganj,

Bihar sees over 2,600 dengue cases this year

Patna, Sept 28: The dengue outbreak in Bihar has seen over 2.600 cases this year. There has been a significant increase in the number of cases since July. Patna is the worst-affected

district, with 1,331 cases reported, including 50 in the last 24 hours alone. Other affected districts Muzaffarpur, Aurangabad, Sitamarhi, Bhagalpur, Munger, Saran, Vaishali, and Samastipur.

Dr Subhash Chandra Prasad, the district infection disease controller, highlighted the rising numbers in Patna, underlining the serious public health challenge posed by dengue in the region.

Dr Subhash Chandra Prasad has said that several localities in Patna, such as Azimabad, Kankarbagh, Patliputra, Bankipur, Patna City, Bakhtiyarpur, Fatuha, Danapur, Dulhin Bazar, Sampat Chak, and Patna Sadar have dengue patients making frequent visits to hospitals. To manage the surge additional dengue wards have been established in key hospitals, including IGIMS, PMCH, NMCH, Patna AIIMS, Kurji Holy Family, as well as other government

"We have urged the public to be vigilant against vector-borne diseases like dengue, which present symptoms such as high fever, headaches, eye and joint pain, and sometimes red spots on the body. In severe cases, nosebleeds or vomiting blood may occur. A district-wide awareness campaign has been launched, advising people with such symptoms to consult doctors," Prasad said.

Dr Bijay Singh, a prominent general physician, emphasised that self-medication often wors-

ens the disease. "It is extremely important to conduct blood tests for diagnosis and maintaining platelet count above 100,000. Risk of internal bleeding increases when platelet count drops below 25,000," Singh said.

Patna, Sept 28: Popular street sports like 'gulel' (slingshot) and ʻgilli danda' (tip cat) will be the flavour of a cultural and sports festival being organised by the Bihar government next month.

The event 'Tarang Art and Sports Festival' (2023-24), which is being organised by the State Council of Educational Research and Training (SCERT), from October 21 to 22 in Patna, aims to provide a platform for children from all over Bihar to showcase their skills in indigenous sports.

The SCERT is the apex academic body in the state for school and teacher education and is a wing of the education department.

Additional Chief Secretary (ACS), Education department, S Siddharth told PTI, "The idea is to simply promote traditional games in schools. The idea is also to make sports more inclusive at the school level. These traditional games—'gulel' and 'gilli danda'--are less resource intensive and will encourage

creativity among students. This is the reason the SCERT



decided to organise a state-level event for these traditional sports,

"There should be multi-dimensional growth of students. The approach should be 360 degree growth of a student. Education should not be limited to books only. We are confident that organizing a state-level sporting event for these traditional games will encourage outdoor play and physical activity among the students," the ACS said.

Commenting on this, Emteyaz

Alam, in charge of department of Physical Education, Art and Craft, said, "These are the games which have great recreational value, give enough exercise to the body and mind of a student. Traditional games can be used as learning tools to help children develop their cognitive, language, social and physical abilities as well.

Jainendra Dost, Lecturer in department of Physical Education, Art and Craft, told PTI, "These games are fast dwindling as the

present generation hardly knows about native games. These games have great recreational value, and will give enough exercise to the body and mind of a student. Such events can be organised at national and international levels also.

Around 1,000 selected students from different government schools across the state will participate during the two-day festival next month.

Besides, 400 students will participate in the state-level com-

pletion of art form. The SCERT has already sent a letter to principals of all College of Teacher Education (CTE), District Institute for Education and Training (DIET), Primary Teacher Education College (PTEC), Block Institute for Education and Training (BIET) and other officials concerned for bringing the selected students from their respective areas to Patna next month, said Dost.



The BJP has no regard for the Constitution or rules and regulations and it is not bothered about ripping off democracy, Atishi alleged. "The LG or the officers do not have the power to call a meeting of the House, yet the LG gave the order, the commissioner obeyed it and called a meeting of the corporation for the election. And instead of the elected mayor, an IAS officer became the presiding officer," she said.

Man, 4 daughters found dead in rented house

New Delhi, Sept 28: The decomposed bodies of a 46-yearold man and his four daughters, two of them differentlyabled, have been found from their rented accommodation in southwest Delhi's Vasant Kunj area, police said Saturday.

The deceased have been identified as Heeralal Sharma, who worked as a carpenter at the Indian Spinal Injury Centre in Vasant Kuni for the last 28 vears. and his four daughters -- Neetu (26), Nikki (24), Neeru (23) and

The bodies, found on Friday afternoon, did not have any injury mark. Police found three packets of celphos poison, five glasses and a spoon containing a suspicious liquid from the house. Police suspect it to be a case of suicide as no evidence of any foul play has been found.

While police said the two youngest daughters of the man were differently-abled, neighbours claimed that all four were physically challenged. The claim is being verified. Deputy Commissioner of Police

(Southwest) Rohit Meena said. According to locals, the women hardly stepped out of their flat. The neighbours claimed that they last saw Sharma and

his daughters September 24. A police official said the bodies were found after the neighbours complained about a foul smell emanating from flat number C4 on the third floor of a residential complex in Rangpuri village.

The DCP said building owner Nitin Chauhan was informed about the smell by the caretaker, following which he

knocked on the door but got no response.

Police broke the door open with the help of a fire brigade team and found Sharma lying dead in one of the rooms, while the bodies of his four daughters were found in

another room, the officer said. The DCP said according to the neighbours and relatives of the deceased, Sharma's wife died of cancer about a year ago. Sharma used to earn around ₹25,000 a month but had not gone to work since January, the officer said.

Gurugram residents living in shadow of garbage dump

Gurugram/Faridabad, Sept **28:** For residents of Haryana's Bandhwari village on the Gurugram-Faridabad border, home to one of the largest landfill sites in the country, elections mean politicians visiting the garbage hill for "photo-ops" and making "mountains of promises".

The locals, meanwhile, continue to struggle with contaminated water; diseases, including difficulty breathing; loss of business, and much more.

Since its inception in 2010, the Bandhwari dumpsite has become a major waste repository in the region, receiving more than 2,000 tonnes per day (TPD) of mixed waste - 1,400 TPD from Gurugram and 600 from Faridabad. Unfortunately, only a small fraction of the waste generated by

the two cities is processed.

For Dharmveer Prajapati, who owns a petrol pump on the Gurugram-Faridabad highway, the landfill poses another challenge.

The ordeal is the same for dhaba owners on the highway that rarely get customers, unlike such eateries on other routes.

"There is a foul smell, mosquitoes and dust are everywhere. so people do not prefer to make a stop here. The situation has worsened in the past few years... It wasn't this bad earlier," said dhaba owner Virender Tanwar.

The landfill is not just a challenge for the villagers but for residents of the swanky apartment complexes nearby. The issue finds mention at the top of both the BJP and the Congress' assembly poll manifestos.

The BJP's Rao Narbir Singh -- a former Haryana minister

The waste has also contaminated the water in the area. From the dumpsite, it seeps into valleys and abandoned mines and contaminates the groundwater. We can't even bathe in the water that comes from the village borewells

The Congress' Badshahpur candidate Vardhan Yaday - making his electoral debut -- said the landfill had been ignored by the BJP despite being in power in the state for 10 years.

The Haryana government has submitted a plan before the National Green Tribunal, committing that the landfill site would be cleared of all legacy waste before December 31.

According to Municipal Corporation of Gurgaon (MCG) Commissioner Narhari Singh Bangar, the landfill's height had been reduced from 50 metres to less than 23 metres in the past two vears. While the MCG assured the tribunal that it would stop dumping fresh waste at Bandhwari as part of the action plan, fresh waste continues to be added to the dump.

Gurugram district has four assembly constituencies --Gurgaon, Pataudi, Badshahpur and Sohna -- with a total

Imphal, Sept 28: The shutdown called by Kuki-Zo groups affected normal life in Manipur's Churachandpur and Kangpokpi districts Saturday, while fresh violence was reported from a village in Jiribam, officials said.

The shutdown was called by Kuki-Zo groups, including the Indigenous Tribal Leaders Forum (ITLF) and Kuki Students Organisation (KSO), in protest against Security Advisor Kuldiep Singh's statement about militants entering the state from outside.

Markets and other commercial establishments remained shut in the two districts, while vehicles staved off the roads, officials said. No untoward incidents have so far been reported, they said.

The shutdown began in the two districts Friday and would continue till Sunday. Singh had September 20 claimed that security forces have taken a number of steps in the wake of reports that "900 militants" who have entered the state might carry out violence in peripheral villages of Imphal valley districts.

The state government Wednesday, however, retracted the statement, asserting that the likelihood of "any such misadventures by armed groups is minimal and unsubstantiated". Meanwhile, fresh violence was reported from a village in Jiribam district, police said.

2 terrorists killed in J&K encounter

Srinagar, Sept 28: Two unidentified terrorists were killed and five security personnel, including an officer, sustained injuries in an encounter in Jammu and Kashmir's Kulgam district, police said Saturday.

The gunbattle broke out in Adigam village in the Devsar area of the district after security forces launched a cordon-andsearch operation there early in the morning. In the early exchange of fire, Additional Superintendent of Police (Traffic) Mumtaz Ali suffered minor injuries due to a stray bullet near the encounter site, officials said.

They said four security personnel involved in the antiterrorist operation sustained injuries in the encounter. Two terrorists were killed, police said, adding that searches are being carried out in the area. The identity and group affiliation of the slain terrorists are being ascertained.

Meanwhile, a Jammu and Kashmir Police head constable was killed and an assistant sub-inspector was injured Saturday evening during an encounter between security forces and terrorists in a remote village in Kathua district, officials said.

The encounter at Kog-Mandli village in Billawar tehsil started around 5.30 pm when security forces launched a joint cordon and search operation following information about the presence of a group of terrorists inside a house, the officials said. They said the firing initially lasted for a brief period but later resumed with both sides exchanging heavy gunfire.

New Delhi, Sept 28: In a bid to curb rising dust pollution during the winter months, Delhi Environment Minister Gopal Rai Saturday unveiled a comprehensive 14-point construction guideline as part of the city's 'Winter Action Plan'.

aim to tackle dust pollution from the construction sites, a major contributor to the city's declining air quality. 'We have made significant strides in reducing air pollution in Delhi, which has decreased by 34.6 per cent over the past nine years," Rai said during a

press conference here

However, during winter, pollution levels spike, largely due to dust from construction activities. Our Winter Action Plan, announced September 25, focuses on 21 areas of concern. with the anti-dust campaign being a key component, he added.

Highlighting 14 points. Rai said that construction sites over 500 square meters must now register on the Construction and Demolition (C&D) portal, where compliance with environmental norms will be strictly monitored.

Those failing to follow the guidelines face hefty fines, while exemplary projects will be recognized with the 'Harit Ratna' Award for their efforts in curbing pollution, he added. The rules also mandate that all construction sites must be covered with tip sheets to prevent dust from spreading into the surroundings.

"People involved in any kind of construction work whether private, government or company-driven must ensure compliance with these rules, Rai emphasiSed.

The minister stated that all construction areas must be enclosed with tin sheets, vehicles transporting construction materials must have clean tires will run from October 7 and materials to November 7 as part of the

New Delhi, Sept 28: One in four diabetic patients are at serious risk of developing heart failure, according to studies conducted in Mumbai and

Delhi-NCR at two labs. An analysis of over 2,000 patient samples from Delhi-NCR by Dr Dangs Lab revealed that 15 per cent of patients with an HbA1c score above 6.5 per cent exhibited elevated levels of NT-proBNP, a crucial biomarker for early heart failure detection,

A study by Joshi of 1,054 patients in Mumbai found that 34 per cent of Type 2 Diabetes Mellitus (T2DM) patients are at increased risk of cardiovascular complications. "People with diabetes, espe-

cially in urban settings, are increasingly vulnerable to heart failure," said Joshi who is an endocrinologist at Bhaktivedanta Hospital in Mumbai. The NT-proBNP test is a critical tool for early detection and allows healthcare providers to intervene before heart damage irreversible. Incorporating cardiovascular screening into routine diabetes care is essential, Joshi added.

Flood mayhem

Kathmandu: Floods and landslides caused by incessant rain killed at least 59 people and injured 36 others in Nepal, officials said Saturday. Parts of Nepal have been inundated with rainfall since Thursday, prompting disaster authorities to warn of flash floods. Nepal Police Deputy Spokesperson Bishwo Adhikari said that out of the 59 people killed in the Himalayan nation due to the continuous rainfall, 34 were killed in the Kathmandu valley. As many as 36 people were also injured in the floods. A total of 44 people remain missing countrywide, with 16 missing in Kathmandu Valley. More than 1,000 people have also been rescued.

Hurricane kills 44

Perry (Florida): Hurricane Helene has left an enormous path of destruction across Florida and the southeastern US, killing at least 44 people. snapping towering oaks like twigs and tearing apart homes as rescue crews launched desperate missions to save people from floodwaters. The Category 4 hurricane knocked out power to some hospitals in southern Georgia, and Governor Brian Kemp said authorities had to use chainsaws to clear debris and open up roads. Moody's Analytics said it expects \$15 billion to \$26 billion in property damage

Pak chopper crash

Peshawar: At least six people were killed when a charter helicopter crashed in northern Pakistan Saturday, security sources said. The two sources, who declined to be named as they were not authorised to speak publicly, said the helicopter was chartered by a private company in northern Khyber Pakhtunkhwa province. It crashed shortly after take-off in the volatile North Waziristan area near the Afghan border. Around 14 including Russian pilots, the sources said, adding that eight people were injured in the crash and hospitalised nearby.

Typhoon damage

Hanoi: Asia's strongest storm this year, Typhoon Yagi. caused damages estimated at 81.5 trillion dong (\$3.31 billion) across northern Vietnam, or twice as much as previous estimates, state media said Saturday, The typhoon, which killed 299 with 34 missing. devastated export-oriented industrial hubs, destroving factories and facilities. besides flooding farmland. damaging homes, and tearing up a bridge. Beirut, Sept 28: Hezbollah leader Hassan Nasrallah, who transformed the Lebanese militant group into a potent paramilitary and political force in the Middle East, was killed in an Israeli airstrike, the group said. He was 64.

Nasrallah, who spearheaded Hezbollah's war against Israel in 2006 and got the group heavily involved in neighbouring Syria's brutal conflict, was killed in a massive Israeli airstrike on the Beirut southern suburb of Haret Hreik Friday evening that knocked down several multistory apartment buildings

REGIONAL WAR FEARS

Nasrallah's death comes amid a dizzving escalation in the nearly yearlong conflict between Israel and Hezbollah, since the war in Gaza started, and more than three decades after he took leadership of the Iranian-backed militant group following the killing of his predecessor by an Israeli missile in 1992. Five years later, the United States designated Hezbollah a terrorist organization.

Hezbollah has been firing rockets, missiles and drones into northern Israel in solidarity with Palestinians in Gaza and Hamas, an allied Iran-



backed militant group. Israel has responded with increasingly heavy airstrikes and the targeted killing of Hezbollah commanders while threatening a wider operation.

This week has been the deadliest in Lebanon since the bruising 2006 month long war between Israel and Hezbollah.

Thousands of pagers and walkie-talkies used mainly by Hezbollah members exploded in different parts of Lebanon, killing 39 people and wounding nearly 3,000, many of them civilians. Lebanon blamed Israel, but Israel did not confirm or deny responsibility. Nasrallah had promised to retaliate.

Nasrallah had said the barrages would continue — and Israelis wouldn't be able to return to their homes in the north — until Israel's campaign in Gaza ended.

17 people killed in 2 mass shootings

Johannesburg: Seventeen people including 15 women were killed in two mass shootings that took place in close proximity to each other in a rural town in South Africa, police said Saturday. A search was underway for the suspects, national police spokesperson Brig. Athlenda Mathe said in a statement. The victims were 15 women and two men, she said. One other person was in critical condition in the hospital. The shootings took place Friday night in the town of Lusikisiki in Eastern Cape province in southeastern South Africa. Video released by police showed that the shootings occurred at two houses in the same neighbourhood, which is a collection of rural homesteads on the outskirts of the town. South Africa has one of the highest homicide rates in the world and mass shootings have become increasingly common in recent years sometimes targeting people in their homes.

Musk's X likely to go online in Brazil

Sao Paulo: Brazilian Supreme Court Justice Alexandre de Moraes has added conditions for Elon Musk's X to have its service reestablished in the country, one day after the social media platform said it had complied with all the judge's demands, including naming a legal representative. De Moraes said in a ruling Friday that X may only be reinstated in Brazil after another company linked to the billionaire, satellite-based internet service provider Starlink, withdraws its appeals related to the case. X has been blocked in Brazil for nearly a month. De Moraes ordered the shutdown after sparring with Musk for months over free speech, far-right accounts and misinformation. His new ruling also established a fine of 10 million Brazilian reais (\$1.84 million).

Washington, Sept 28: The US announced an agreement with the Iraqi government Friday to wrap up the military mission in Iraq of an American-led coalition fighting the Islamic State group by next year, with US troops departing some bases that they have long occupied during a two-decade-long military

presence in the country.

But the Biden administration refused to provide details on

how many of the approximately 2,500 US troops still serving in Iraq will remain there or acknowledge it will mark a full withdrawal from the country.

"I think it's fair to say that, you know, our footprint is going to be changing within the country," Pentagon deputy press secretary Sabrina Singh told reporters Friday without providing specifics.

Bases housing US forces and contractors have been regularly targeted by Iran-backed militias



over the last several years, and those attacks intensified late last year and early this spring after the Israel-Hamas war broke out nearly a year ago

For years, Iraqi officials have periodically called for a withdrawal of coalition forces, and formal talks to wind down the US presence in the country have been going on for months.

US officials who briefed reporters Friday said the agreement will bring about a twoThe agreement marks the third time in the last two decades that the US has announced a formal transition of the military's role in Iraq

phase transition in the troops assigned to Iraq that began this month. In the first phase, which runs through September 2025, the coalition mission against ISIS will end and forces will

leave some longstanding bases. Following the November election, American forces will start departing from Ain al-Asad airbase in western Iraq and from Baghdad International Airport, according to Iraqi government officials who spoke to The

Associated Press on the condition of anonymity. Those forces will be moved to Hareer base in Erbil, in northern Iraq's Kurdistan region.

In the second phase, the US will continue to operate in some fashion from Iraq through 2026 to support counter-ISIS operations in Syria, a senior Biden administration official and a senior defence official said on the condition of anonymity on a call with reporters to provide details ahead of the announcement.

Ultimately, the US military mission would transition to a bilateral security relationship, the US officials said, but they did not indicate what that might mean for the number of American troops who remain in Iraq in the future.

HDB Financial prepares for IPO

New Delhi: After the mega public issue of Bajaj Housing Finance, another upper layer NBFC, HDB Financial Services has initiated the process to tap the IPO market and is expected to file draft papers soon to meet the RBI's mandatory listing requirements. HDB Financial Services last week received approval from the board of its parent company, HDFC Bank, to begin the process of going public. The board approved an initial public offering (IPO) consisting of a fresh issue of shares worth up to ₹2,500 crore and an offer for sale (OFS) by existing shareholders. HDB Financial Services is expected to file the draft papers with the Securities and Exchange Board of India (Sebi) soon, merchant bankers said.

NHPC inks JV pact for RE

New Delhi: State-owned NHPC Saturday said it has inked a joint venture agreement with APGENCO for implementation of pumped storage hydro power projects and other renewable energy projects in Andhra Pradesh. In first phase, two pumped storage projects (PSPs) Yaganti (1000 MW) and Raiupalem (800 MW) - are considered for joint implementation. Subsequently, other projects shall be identified in next phase, a company statement said. The agreement was signed between NHPC Chairman & Managing Director RK Chaudhary and APGENCO Managing Director KVN Chakradhar Babu in the presence of Chief Minister N Chandrababu Naidu.

Pidilite invests ₹5cr in home Wify

New Delhi: Adhesive and construction chemicals manufacturer Pidilite Industries has invested ₹5 crore in Wify, a home improvement and maintenance services platform. This pre-series A funding round was led by Capria and Mount Judi Ventures, with participation from Blume Ventures. The investment was done through Pidilite Ventures, a wholly-owned subsidiary of Pidilite Industries, according to a statement. "The investment from this round will fuel Wify's growth, enabling them to enhance their tech stack, expand services, and strengthen their market position," it said.

Banks struggle to mobilise deposits

New Delhi, Sept 28: Banks struggled to mobilise large deposits to meet the increasing credit demand in the last two financial years, a report said.

Outstanding credit disbursed by Scheduled Commercial Banks (SCBs) was at the highest level in 2023-24 amounting to ₹1,64,98,006 crore, whereas in percentage terms, the growth of Credit-to-Deposit(C-D) ratio rose from 75.8 per cent to 80.3 per cent, Infomerics Ratings said in a report.

According to the RBI April 2024 Bulletin, during March 2024, the incremental Credit-Deposit Ratio(ICDR) remained around 95.94 per cent, whereas on March 8, 2024 this was at 92.95 per cent.

It may be observed that there was a much higher growth of credit of the SCBs compared to the growth of deposits, even as per the Quarter-on-Quarter (QoQ) basis, it said.

The growth of credit outpaced the growth of deposits during the period FY'19 to FY'24.

Alternative investments and substantial cash holdings in the unorganized sector slowed deposit accumulation, particularly in rural areas, it said.

It is interesting to note that the proportion of individual in-



vestors under 30 years old rose steadily, with their share in the registered investor base growing from 22.6 per cent as of FY19 to 39.9 per cent as of FY25 (as on July 31, 2024).

This trend demonstrates an increasing interest in equity markets among young investors,

During the same period, it said, the share of investors aged 30-39 remained relatively stable. while the share of those over 40 declined.

In order to increase the deposit ratio, banks and Government must make ioint efforts. True North Financial Services CEO

Banks need to return to the old trend of raising small ticket deposits from the retail public which has historically been the strength of the country rather than pursuing bulk corporate deposits, he said.

Moreover, Bakshi said, a noticeable trend is that 47 per cent of term deposits are held by senior citizens which implies that the younger generation is not attracted towards bank deposits.

"Government should consider reducing the tax on interest especially at the highest tax slab. Also, it may consider taxation at the time of maturity of fixed deposit rather than the present system of taxation at yearly accrual," he added.

GST Council sets up GoM on compensation cess

New Delhi, Sept 28: The Goods and Services Tax (GST) Council has set up a 10-member GoM, chaired by Minister of State for Finance Pankaj Chaudhary, to decide on the taxation of luxury, sin and demerit goods once the compensation cess ends in March 2026.

The Group of Ministers (GoM), which includes members from Assam, Chhattisgarh, Gujarat, Karnataka, Madhya Pradesh, Punjab, Tamil Nadu, Uttar Pradesh and West Bengal, will submit its report to the Council by December 31.

In the GST regime, compensation cess at varied rates is levied on luxury, sin and demerit goods over and above the 28 per cent tax. The proceeds from the cess, which was originally planned for five years after GST roll-out or till June 2022, were used to compensate states for revenue loss incurred by them post the introduction of GST.

In 2022, the Council decided to extend the levy till March 2026 to repay the interest and the principle amount of the ₹2.69 lakh crore worth loan taken in the 2021 and 2022 fiscal years to make good states' revenue loss during Covid years.

With just one-and-a-half year remaining for the cess to end, the GST Council in its 54th meeting on September 9 decided to set up a GoM to decide the future course of the cess.

Gold reserves rise, ETF buying surges

New Delhi, Sept 28: India's gold reserves are increasing on a regular basis and according to experts, bullion is likely to remain supported by safe-haven demand and strong buying among gold exchange-traded fund (ETF) investors.

As per latest data by the Reserve Bank of India (RBI), gold reserves increased by \$726 million to \$63.613 billion, compared to \$62.887 billion last week.

Gold is the second largest contributor to India's forex reserve. India's foreign exchange reserves have scaled a new high

\$692.296 billion, up by \$2.838 billion in the week that ended September 20. As per global financial firms, the forex reserves are at record all-time high levels and are set to cross \$700 billion in FY25 sooner than expected.

According to a latest note by global investment firm Jefferies. RBI's forex reserve is estimated to go up by a massive \$53 billion to reach \$700 billion in the current fiscal (FY25E).

Experts said India's strong forex will boost economic growth trajectory by strengthening its position internationally, drawing in foreign investments, and promoting domestic trade and industry.

Notably, Special Drawing Rights (SDRs) increased by \$121 million to \$18.540 billion as of



previous level of \$18.419 billion September 13.

tion with the International Monetary Fund (IMF) fell \$65 million to \$4.458 billion as of the latest data filing. The central bank intervenes

in the foreign exchange market to keep the volatility in the Indian currency in check.

Iron ore output rises India allows export of non-basmati rice 7.4% in April-August

New Delhi, Sept 28: The production of iron ore and manganese ore witnessed a growth during the April-August period of the ongoing fiscal.

The output of iron ore rose by 7.4 per cent to 116 million tonnes (MT) during the said period compared to 108 MT registered in the corresponding period of previous fiscal, according to a provisional data released by the mines ministry.

The production of manganese ore jumped by 15.4 per cent to 1.5 MT during the April-August period as compared to 1.3 MT in the previous financial year, the ministry said in a statement.

Iron ore accounts for about 70 per cent of the total mineral production in terms of value.

In the non-ferrous metal sector, primary aluminium production rose to 17.49 lakh tonnes (LT) during April-August from 17.26 LT in the year-ago period.

"During the same comparative period, refined copper production has grown by $5.8~\mathrm{per}$



cent from 1.91 LT to 2.02 LT," the largest aluminium producer, among top 10 producer of refined copper and fourth largest iron ore producer in the world.

Continued growth in production of iron ore in the current financial year reflects the robust demand conditions in the user industries, mainly steel.

Coupled with growth in aluminium and copper, these growth trends point towards continued strong economic activity in user sectors such as energy, infrastructure, construction, automotive and machinery, the state-

New Delhi, Sept 28: India gave the go-ahead Saturday for exports of non-basmati white rice to resume as inventories in the world's biggest exporter of the grain surge and farmers prepare to harvest a new crop in the coming weeks.

Bigger rice shipments from India would beef up overall global supplies and soften international prices by forcing other major exporters of the staple such as Pakistan, Thailand and Vietnam to reduce their rates, traders said.

New Delhi set a floo for non-basmati white rice exports of \$490 per metric ton, a government order said. That came a day after the government cut the export tax on white rice to zero.

New Delhi's decision to allow traders to sell non-basmati white rice on the world market follows a series of moves to ease export restrictions on premium, aromatic basmati and parboiled varieties. Friday, India also reduced the export duty on parboiled rice to 10% from 20% previously.

Earlier this month, the gov-



ernment removed a floor price for basmati rice exports to help thousands of farmers who complained about a lack of access to lucrative overseas markets such as Europe, the Middle East and the United States.

As the El Nino weather pattern raised the spectre of poor monsoon rains, India imposed various curbs on rice exports last year and extended them into

The benchmark indices saw a phase of sector rotation. Largecap stocks are receiving more inflows compared to mid and small-caps, which had been market favourites until recently.

Sectors like public sector banks, defence and railways, which saw heavy participation earlier, are gradually being overshadowed by under-performers such as pharma, private banks and mid-size IT.

These sectors, with their attractive valuations, are likely to lead the next market phase for the coming quarters, according to Krishna Appala from Capitalmind Research.

cent, making it the best-performing sector, followed by CNX Auto, which gained 3.5 per cent.

Shuttlers bow out

Macau: Indian pair Treesa Jolly and Gayatri Gopichand's women's doubles campaign at the Macau Open Super 300 badminton tournament came to an end as they lost to Chinese Taipei's Hsieh Pei Shan and Hung En-Tzu in the semifinals here Saturday. The thirdseeded Indian duo fought hard but lost 17-21, 21-16, 10-21 to the world No 54 Chinese Taipei pair, bringing India's journey at the tournament to a close. Ranked 23rd in the world, Treesa and Gayatri had already faced defeat against Hsieh and Hung twice this year, but they looked determined to turn the tables this time.

Musheer Khan stable

Lucknow: Mumbai all-rounder Musheer Khan, younger brother of India batter Sarfaraz, is "stable" after suffering a road accident on the outskirts of Lucknow but is set to miss cricketing action for a prolonged period starting with the upcoming Irani Cup. The 19-yearold is expected to be out of action for at least three months due to neck injuries he sustained in the accident, effectively ruling him out of Mumbai's matches at the start of the Ranji Trophy 2024-25 season, starting from October 11. It is learnt that Musheer was en route to Lucknow from Azamgarh, his hometown, for the Irani Cup beginning October 1. He was accompanied by his father Naushad Khan, who also suffered minor scratches in the accident that took place on the Purvanchal Expressway after his car hit a divider and overturned.

Bopanna-Dodig lose

Beijing: Indian tennis star Rohan Bopanna and his Croatian partner Ivan Dodig suffered a shock loss to the pair of Francisco Cerundolo and Nicolas Jarry in a first round match of the China Open ATP 500 tournament here Saturday. The second-seeded Indo-Croatian pair lost 5-7 6-7 to the unseeded Cerundolo (Argentina) and Jarry (Chile) duo in the round of 16 match that lasted one hour 31 minutes. Bopanna's regular partner Matthew Ebden of Australia chose not to participate in the ATP 500 event. Bopanna has had stints partnering Dodig in the past -- in 2017 and 2021 -- with their best result being reaching the final at the 2017 ATP Montreal Masters 1000 event. The 44-year-old Indian won two titles this year -- Australian Open Grand Slam event and Miami Open.

Sinner in trouble

Rome: The steroid case involving top-ranked tennis player Jannik Sinner was appealed by the World Anti-Doping Agency, the Montrealbased body known as WADA, announced Saturday. WADA said it is seeking a ban of one to two years indicated that it does not plan to back date an eventual ban - which would mean that Sinner could keep his second Grand Slam title if he is found guilty. Sinner tested positive twice for an anabolic steroid in March but was not banned in a decision by an independent tribunal announced by the International Tennis Integrity Agency (ITIA) August 20 because the ITIA determined he was not to blame.

Martínez suspended

Buenos Aires: Argentina's soccer association (AFA) said that FIFA suspended goalkeeper Emiliano Martínez for two matches of South American World Cup qualifying in October. The decision rules out the 32-year-old from official games in the round-robin competition against Venezuela and Bolivia October 10 and 15. AFA said in a statement that FIFA's disciplinary commission sanctioned Martínez due to incidents in two World Cup qualifying matches against Chile and Colombia earlier this month. The soccer body did not describe which incidents led to the punishment. Martínez made an obscene gesture after his team's 3-0 win against Chile by holding the Copa America trophy close to his genitals, as he did after the South American team lifted the World Cup title in Oatar in the end of 2022. Later, he slapped a local cameraman after Argentina's 2-1 defeat against Colombia in Barranguilla.

Tvesa, Pranavi miss cut

Deauville: Indian golfers Pranavi Urs and Tvesa Malik faced disappointment at the Lacoste Ladies Open de France, as both missed the cut after struggling in their second rounds here. Pranavi carded 79 after a first-round 72 to miss the cut by a big margin, while Tvesa, who shot 72 in the first round, added 76 and missed by one shot as the cut fell at 5-over 147.

India's WTC final hopes in limbo Usha vs 'Dozen'

Big blow to India's World Test Championship final hopes if 2nd Test vs Bangladesh is washed out

Kanpur, Sept 28: Rain and a wet outfield have played spoilsport in the second Test between India and Bangladesh at Green Park Stadium, with the weather threatening to derail India's quest for a spot in the World Test Championship (WTC) final.

Only 35 overs were bowled on Day 1 as Bangladesh struggled to 107/3, with Indian pacer Akash Deep impressing by picking up two crucial wickets. The second day was washed out without a ball being bowled

As it stands, India lead the WTC standings with a percentage points (PCT) tally of 71.67 after 10 matches, putting them in a prime position to make their third consecutive final. A 2-0 series win over Bangladesh would

have left India needing only three more wins from their remaining eight matches to secure a spot in the WTC final.

However, with rain looming large over the second Test, a draw could complicate India's path to the final.

Should this Test ended in a draw, India will need to win five of their next eight Test matches to cement their place in the WTC final, assuming other contenders for a top-two finish do not drop points.

This leaves India with a more challenging route, as they will likely need to clean sweep New Zealand 3-0 at home and secure at least two wins in the fivematch Border-Gavaskar series against Australia in Down Under.

India have won the last two series in Australia, but re-

peating that feat will be a daunting task, especially with the pressure of WTC qualification hanging over their heads. The team's dominant record at home, combined with their recent successes Down Under, gives India some confidence, but the margin for error has narrowed considerably if this match is washed out.

The series against New Zealand at home will be pivotal in shaping India's campaign. While the Indian side has been virtually unbeatable on home soil, a 3-0 sweep against the Kiwis is crucial to lessen the burden of needing to win several games away in Australia.

Given India's history in Australia, two wins in the Border-Gavaskar series would still be an impressive result,

BCCI introduces match fee for IPL, franchises asked to give ₹12.60cr

Mumbai, Sept 28: To make playing the Indian Premier League (IPL) more lucrative for the players, the Board of Control for Cricket in India (BCCI), the owner of the league, has decided to introduce a match fee for every game, which will be over and above the contracted amount for which a player is signed up.

Terming it a historic move, BCCI secretary Jay Shah said in a post on X, formerly Twitter. that BCCI has introduced a match fee of ₹7.5 lakh per game for the players to celebrate consistency and outstanding performances. The move will come into effect from the upcoming 2025 edition of the IPL.

Each franchise will allocate ₹12.60 crore as match fees for the season and thus, a player playing all league matches in a season will earn an additional ₹1.05 crore, Shah wrote in his post.

"In a historic move to celebrate consistency and champion outstanding performances in the #IPL, we are thrilled to introduce a match fee of INR 7.5 lakhs per game for our cricketers! A cricketer playing all league matches in a season will get ₹1.05 crore in addition to his contracted amount," wrote Jay Shah in his post.

"Each franchise will allocate INR 12.60 crores as match fees for the season! This is a new era for the #IPL and our players!" he further wrote.

Currently, players get the contracted amount at which they were picked in the auction or through retention. Besides that, they also get a portion of the Player of the Match award for being a part of the Playing XI.

But the introduction of a match fee will definitely help the uncapped and young players like U-19 stars as they have a salary cap and are signed up at a nominal amount when compared to the megabucks offered in the auction.

With the introduction of match-fee, these players will get an additional ₹7.9 lakh if they play a match, thus making playing in the IPL a more lucrative proportion for them.

Wimbledon gets nod for expansion plan

The All England Club's proposal to build 39 new

courts, including an 8.000-seat show court was passed by London's deputy mayor for planning

London, Sept 28: Wimbledon have been given the green light to go ahead with their controversial plans to expand the historic venue for the grass-court Grand Slam.

The All England Club's proposal to build 39 new courts, including an 8,000-seat show court, on the adjacent former Wimbledon Park Golf Club was passed Friday by London's deputy mayor for planning Jules Pipe. Wimbledon will nearly triple the size of its current site once the project is completed.

Plans were first submitted in 2021, but there had been strong local opposition from groups such as 'Save Wimbledon Park' and environmental protestors who claimed the harm caused to open land was not justified.

The issue had become increasingly acrimonious, but Friday's decision was expected



after Greater London Authority planning officers recommended permission be granted due to the financial and community benefits. "In summary, the proposed development would facilitate very significant benefits," Pipe said. "I agree with my officers that these benefits clearly outweigh the harm."

Central to Wimbledon's case has been the desire to hold its qualifying competition, which is currently staged over three miles away in Roehampton, on its own land. All England Club chair Debbie Jevans said: "We are delighted that the Greater

London Authority has resolved to approve our applications to transform the former Wimbledon Park golf course. Our proposals will deliver 27 acres of newly accessible parkland for the community and enable us to bring the qualifying competition for The Championships onsite, with all of the substantial economic and employment opportunities this presents.

The Mayor of London's office took charge of the application in January after Merton Council approved the plans and Wandsworth Council rejected

them late last year. Mayor Sadiq Khan recused himself from the process having previously expressed public support for the development, leaving the matter in Pipe's hands.

Fleur Anderson, the MP for Putney, claimed allowing the scheme would set "a dangerous London-wide and national precedent". But Jevans said: "We look forward to working with all parties to bring this vision to life, delivering one of London's greatest sporting transformations since the 2012 Games and securing Wimbledon's future at the pinnacle of world sport.

AITA elects new office bearers, holds official declaration of result

New Delhi, Sept 28: The All India Tennis Association (AITA) Saturday elected unopposed a new set of office bearers but the result was not declared officially as per the directions of the Delhi High Court, which is hearing a petition into Sports Code violations by the federation.

The AITA was to conduct election at its Annual General Meeting (AGM) but there was no need for voting since the Returning Officer received only one nomination for each post.

Apart from getting a new President, secretary general and treasurer, the national tennis federation elected eight vice presidents, four joint secretaries and 10 executive members.

It has been learnt that initially Rohit Rajpal and one more candidate had filed their nominations for the post of President but later India's non-playing Davis Cup captain withdrew his candidature. Former India players Somdev Devvarman and Purav Raja had sought a stay on the AITA elections, claiming that the federation was not following the Sports Code and several candidates in fray were ineligible to contest the polls.
